- 3. The Divisional Forest Officer, Churachandpur With a request to submit estimates for logging/transportation and dwarf plantation etc.to this office for onward submission to NHIDCL. They are requested to see that all provisions of IPA are complied with by the UA.

Sub: Proposal for diversion of 94.752 ha of forest land for widening & improvement of Churachandpue – Tuivai Road section of NH-102B into two laning of existing 73.000 km from G.Bualjang village to Songtal village of 134.279 km in the State of Manipur on EPC mode by NHIDCL.

Sir,

This has got reference to the State Government of Manipur letter No. RR-102/2/2021-FE-Dept(For & Envt) dated 16.01.2021on the subject mentioned above seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the proposal of the State Government of Manipur and the additional information submitted vide their letter No.RR-102/2/2021-FE-Dept(For-Evt) dated 26.03.2021 and on the recommendation of the proposal in the Regional Empowered Committee (REC) in its meeting held on 09.06.2021, the In-principle / Stage-I approval of the Central Government is hereby granted for diversion of 94.752 ha of forest land for widening & improvement of Churachandpue — Tuivai Road section of NH-102B into two laning of existing 73.000 km from G.Bualjang village to Songtal village of 134.279 km in the State of Manipur on EPC mode by NHIDCL, subject to the following conditions:

# A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

- 1. The user agency shall transfer, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the orders of the Hon'ble Supreme Court of India dated 28/03/2008, 24/04/2008 and 09/05/2008 in Writ petition (Civil) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No 5-3/2007-FC dated 05.02,2009. The requisite funds shall be transferred through online portal into CAMPA account of the State concerned;
- 2. The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The scheme may include appropriate for anticipated cost increase for works scheduled for subsequent years;

- The user agency shall transfer the cost of raising Avenue plantation on the road side with the State Forest Department;
- 4. All the funds received from the user agency under the project shall be transferred/deposited to CAMPA account only through e-portal(https://parivesh.nic.in). Amount deposited through other made will not be accepted as compliance of the Stage-I clearance;
- 5. The User Agency shall transfer Rs.20 Lakhs to the State Forest Department for Exsitu Bio-diversity Conservation Garden to be established at Churachandpur Forest Division.
- 6. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the District Collector;
- 7. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-Fe dated 28.03.2019;
- 8. The cost of felling of trees shall be deposited by the User Agency with the State Forest Department;
- The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from the pillar to pillar and GPS co-ordinates;
- 10. The compliance report shall be uploaded on e-portal ( https://parivesh.nic.in/ );
- B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:
  - 1. Legal status of the diverted forest land shall remain unchanged;
  - 2. Compensatory Afforestation shall be raised over double the area to be diverted i.e. 189.50 ha in the degraded forest land identified in Dampi Reserve Forest in 3 (three) patches i.e. 69.0 ha in Nuanjang, plot 1 C/No 16; 60 ha in Nuamjang, plot 2 C/No 4 & 16 and 60.5 ha in Mualvaiphai C/No. 19 under Churachandpur Forest Division, Churachandpur;
  - 3. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;
  - 4. The User Agency shall obtain the Environment Clearance as per the provisions of Environment (Protection) Act, 1986, if required;

- The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government;
- 6. No damage to the flora and fauna of the adjoining area shall be caused;
- 7. The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area;
- The User Agency shall submit the annual self-compliance report in respect of the above stated conditions to the State Government, concerned Regional Office and to this Ministry by the end of March every year;
- 10. The user agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project;
- 11. All other clearance/NOCs under different applicable rules/regulations /local laws and under Forest Dwellers (Recognition of Forest Rights)Act, 2006 as required vide MoEF, New Delhi guideline No.11-9/1998-FC(pt) dated 03.08.2009 shall be complied with;
- 12. As per Ministry's letter No 11-30/96-FC(Pt) dt 14.9.2001, if the compliance of stipulated conditions is awaited from the State Govt for more than 5(five) years, the in-principle approval would be summarily be revoked considering that the user agency is no longer interested in the project.
- 3. After receipt of the compliance report from the State Government on fulfilment of the conditions mentioned above, final approval will be issued in this regard. Formal transfer of forest land shall not be effected by the State Govt till final approval is granted by the Central Government.
