With reference to the "In Principle Approval" accorded by Govt. of India vide letter under reference above for diversion of 56.833 ha of forest land for construction of "132 kV Transmission Line from Rengang- Tamenglong" uder NERPSIP by MSPCL, the parawise compliance against the conditions stipulated in the In-principle approval is submitted as below:

ii)	The compensatory afforestation shall be taken up by the Forest Department over double degraded forest land of 114.00 ha at 2 (two) locations i.e. 30.00 ha in Rengpang, Nungba Range, Noney Forest Division and 84.00 ha in Keikao & Lower Tamenglong, Tamenglong Range, Western Forest Division both in Tamenglong district at the cost of the User Agency. As far as possible, mixture of local indegous species shall be planted and monoculture of any species may be avoided.	Pertains to the State Forest Dept.
iii)	The cost of the compensatory afforestation at the prevailing wages as per the compensatory afforestation and dwarf species plantation shall be deposited in the Compensatory Afforestation Fund of Manipur State manage by the Adhoc CAMPA through e-portal in the account of the Ad-hoc CAMPA. x)	The expenditure like boundary walls, stone pillars and demarcation charges cost of damage of trees, the fund on these accounts, should be deposited with DFO concerned.	
xi)	The user agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees should be felled under strict supervision of State Forest Department and the cost of the felling of trees shall be deposited by the user agency with the State Forest Department.
