

After due consideration of the proposal of the State Government and on the decision of Regional Empowered Committee in its 4th meeting of 2024 on 12/03/2024, "in-principle" approval of the Central Government, is hereby conveyed for diversion of 109.496 ha forest land (79.9776 ha in Sagar North & 29.5184 ha in Chhatarpur Forest Division) for improvement and upgradation of existing 2-lane to 4-lane with paved shoulders with/without service road including realignment and Shahgarh & Hirapur bypasses from Mohari to Satai Ghat Section of NH-34 (old NH-86 Sagar-Kanpur) from design km. 50+300 (existing km. 49.789) to Design km. 89+878 (existing km. 90.302) under Bharatmala Pariyojna (Package-2) in Sagar and Chharpur Districts of Madhya Pradesh, subject to following conditions and stipulations:

- A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department
- (1)Cost of compensatory afforestation on the 220.00 ha degraded forest land at prevailing wage rates as per compensatory afforestation scheme (including cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provisions for anticipated cost increase for the works scheduled for subsequent years.

- (9) The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).
- (10) In case working permission is granted by the State Forest Department, a copy of the same shall be submitted along with compliance report of Stage-I approval.
- B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval
- (1) Legal status of the forest land shall remain unchanged.

- (3) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- (4) The User Agency shall restrict felling of trees to the enumerated 25377 numbers/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department and State Forest Department shall undertake the fellings.
- (5) Boundary of the diverted forest land shall be suitably demarcated on the ground at the project cost.

- (9) No labour camp shall be established on the forest land.
- (10) The User Agency shall provide alternate fuels preferably LPG to the labourers and staff working at the site so as to prevent any damage and pressure on the nearby forests.
- (11) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- (12) The period of diversion under this approval shall be co-terminus with the project life.
- (13) The forest land shall not be used for any purpose other than that specified in the project proposal.
- (14) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any for the time being in force, as applicable to the project.
- (15) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of the Central Government.
- (16) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forest & wildlife.
