In continuation with this office ltr. no.1211 dtd. 13.11.2023 the compliance of the EDS raised by IRO, MoEF & CC, Govt. of India is as follows

**Point No.1:-**

**The State Govt. has submitted the instant Stage-I compliance report after lapse of more than 5 years, as per Ministry's letter No. 5-3/2011-FC (Vol-I), dated 22.03.2023 the new rate of NPV is applicable to the instant project. Hence, NPV at new rate may be realized from the user agency**

**Compliance:-**

As per demand letter no. 5393 dated 07.09.23 by Divisional Forest Officer, Sambalpur Forest Division; we have deposited Rs.31,32,335/- dated 07.11.2023 to CAMPA A/c No. 150825722787326 The copy of the Challan and Bank receipt is enclosed as an Annexure-I

**Point No.2:-**

**The State Govt. has submitted Stage-I compliance report on 30.05.2023 after lapse of more than 5 years. As per rule 8(3) (d) of Forest (Conservation) Rules, 2003, valid and cogent reasons for delay in submission of compliance of stipulated conditions of in-principle approval has not been submitted**

**Compliance:-**

As regards to compliance for stage-1 forest clearance, the following compensatory levies/funds have already been deposited by this office: -

1. As per demand Memo No. 2845 Dtd 29.05.2018 of DFO Sambalpur for Net Present Value (NPV) of the Reserve Forest land Rs. **59, 10, 066/-** has been deposited to Adhoc CAMPA on date 29.06.2018.
2. As per demand Ltr No. 7354 Dtd 16.07.2018 of DFO Bonai for Cost of Compensatory Afforestation of **Rs. 23, 17, 800/- @ Rs.213.50 per Mandays(MD)** has been deposited to Adhoc CAMPA on date 30.07.2018.
3. As per demand Memo No. 475 Dtd 15.02.2019 of DFO Sambalpur for Differential Compensatory Afforestation, **Rs.1,81,200/- @ Rs.280.00 per MD** has been deposited on date 04.05.2019.
4. As per demand Memo No. 5644 Dtd 30.09.2022 of DFO Sambalpur for Differential Compensatory Afforestation, **Rs. 22,52,500/- @ Rs.326.00 per MD** has been deposited on date 21.10.2022.
5. As per demand Memo No. 1878 Dtd 22.03.2023 of DFO Sambalpur for Differential Compensatory Afforestation, **Rs.40,700/- @ Rs.333.00 per MD** has been deposited on date 29.03.2023.

6. As per demand Memo No. 1084 Dtd 13.02.2020 of DFO Sambalpur for Cost for 11, scheme for plantation of 10 times the number of plants to be felled from non-forest land of project, **Rs 5,07,51,044/-** has been deposited DFO, Sambalpur on date 24.03.2020.
7. As per demand Memo No. 2898 Dtd 20.08.2018 of O/o GM, OFDC Sambalpur Zone for Felling cost of 1847 trees standing in non-forest land of the villages Taranagar and Jamada (Phase-I) of **Rs. 43, 69, 328/-** deposited with OFDC, Sambalpur on date 21.12.2018.
8. As per demand Memo No. 193 Dtd 01.02.2019 of O/o GM, OFDC Sambalpur Zone for Felling cost of 2699 trees standing in non-forest land in village Taranagar, Garmunda, Solpali and Solband (Phase-II) of **Rs. 52,99,118/-** deposited with OFDC, Sambalpur on date 21.02.2019.
9. As per letter No. 973 Dtd 25.04.2019 of O/o Divisional Manager, Sambalpur (CKL) Division for Felling cost of 115 trees standing in the Lamdunguri RF of **Rs. 61,525/-** deposited with OFDC, Sambalpur on date 13.02.2020.
10. As per demand Memo No. 2917 Dtd 01.06.2018 of DFO Sambalpur for Cost of royalty for 1847 trees standing in non-forest land of the villages Taranagar and Jamada (Phase-I), **Rs.23, 39, 330/-** deposited with Tahsildar, Sambalpur on date 30.07.2018 .
11. As per demand Memo No. 5563 Dtd 05.11.2018 of DFO Sambalpur for Cost of royalty for 2699 trees standing in non-forest land in village Taranagar, Garmunda, Solpali and Solband (Phase-II) of **Rs 15, 98, 093/-** deposited with Tahsildar, Sambalpur on date 22.12.2018.

Further, the non-forest land of 9.441 ha identified after for raising compensatory afforestation at Kello village under Bonai Tahasil of Sundergarh district has already been transferred and mutated in favour of the Forest Department Government of Odisha vide Order No.45/Res Dtd.11.01.2020 of O/o the Collector & District Magistrate, Sundargarh. The above non forest land has been notified as Kello Protected Forest vide notification No.FE-DIV-FLD-0102-2021-15724/FE&CC Dtd.03.09.2021 of Forest, Environment & Climate Change Department, Government of Odisha.

The compliance of the observation raised by the Principal Chief Conservator of Forests & HoFF, Bhubaneswar has also been submitted to your good office vide this office letter No.380/WE Dtd.31.03.2023 & ltr. No. 436/WE dtd. 05.04.2023 respectively.

Further, it is to apprise your good office that compliance of all the conditions were completed, however, it took more time due to following reasons:

1. On account of COVID-19 situation for two years
2. Revision of Labour Wages and again it took more time for approval by CA Scheme by the PCCF, Nodal. The CA Scheme has been approved by the PCCF, Nodal on 17.03.2023 and the differential amount of CA has been deposited on 29.03.2023 after receiving the demand note from the Divisional Forest Officer, Sambalpur Forest Division on 23.03.2023.
3. Due to local agitation of Bar Association of Sambalpur demanding the bench of Odisha High Court for which the local offices were closed frequently.

This is for favour of your kind information and necessary action.

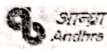

As per the condition No.-V imposed in stage - I clearance, the non forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of state Forest Department before issue of Stage -II approval.
