Sir,

This has reference to the letter on the subject cited above, we would like to inform you that Ministry of Environment, Forest and Climate change, Govt. of India has accorded approval of the Central Government under Section 2 (iii) of the Forest (Conservation) Act, 1980 in favour of M/s Raga Tradecon Pvt. Ltd. for grant of mining lease over 66.242 ha of forest within Netrabandha Pahar (west) iron ore block in Villages Baldihi and Sanua under Bonai Forest Division of Sundergarh District of Odisha State. We here by accept the same and furnishing the compliance to the conditions stipulated as follows:-

- i. Legal status of the forest land shall remain unchanged;

*In compliance to the above, an undertaking to this effect is enclosed as Annexure -1 that the legal status of the forest land shall be remain unchanged.*

- ii. The State Government shall ensure that NPV, in lieu of the forest land under consideration will be realized from the user agency, in accordance with MoEF&CC's guidelines dated 06.01.2022 read with guidelines dated 22.03.2022 and deposited, through e-challan, in to the CAMPA account of the State concerned;

The user agency shall be responsible for the protection of the forest land located in the mining lease. However, administrative and management control of such forest land will remain with the State Forest department or other forest land owning agencies;

*In compliance to the above, we here by undertake that breaking up of land or mining operations within the lease area shall be carried out after obtaining prior approval of the Central Govt. under Section 2 (ii) of Forest (Conservation) Act, 1980. We further undertake that we shall ensure the protection of the forest land located in the mining lease under the guidance of Forest Department. 


