With reference to the letter on the subject cited above, it is inform you that three nos of Encroachment cases (4-115/2024, 4-116/2024 and 4-117/2024) have been instituted under OPLE Act 1972 by Tahasildar, Harabhanga vide his letter no 724//Rev-III-09/2024 dt 17.02.2024 against Boudh Distillery Pvt. Ltd, Boudh. The Boudh Distillery Pvt. Ltd, Boudh has also given in writing to pay the penalty and assessment in obedience to the order of Tahasildar, Harabhanga.

So far as the action against the erring Revenue Officials are concerned, it is to mention here that , they had been retired from Govt. Service since long.

But as per the observation of D.I.G. of Forest (C) all the Revenue Officials have been adequately sensitized not to commit such type of violation in future rather to pay due diligence to law of the land in general, to Forest Conservation Act in particular.

In view of the above facts and circumstances the matter may please be intimated the Govt. in FE&CC Deptt for their kind consideration with a request to drop the case.
