





## 1. Legal Status of the diverted forestland shall remain unchanged.

- In compliance to the above, GAIL has submitted an undertaking that the legal status of diverted forest land shall remain unchanged. An undertaking is enclosed as Annexure-1.

## 2. Compensatory Afforestation:

### i. Compensatory Afforestation over degraded forest land, double in extent to the forest land being diverted i.e. 4.2 ha, shall be raised by the State Forest Department at the project cost within two years from the date of grant of final approval.

- In compliance to the above, GAIL has submitted an undertaking which is enclosed as Annexure-2(i).

### ii. The User Agency shall transfer the cost of raising and maintaining the compensatory afforestation as per the approved CA Scheme at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal.

- In compliance to the above, GAIL has transferred an amount of Rs 58,09,700/- vide UTR no. SBINR52025031078012573 dt. 10.03.2025 towards the cost of raising and maintaining the compensatory afforestation as per the approved CA Scheme at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The copy of demand notes and payment receipt is enclosed as Annexure 2 (ii).

### iii. The cost of survey, demarcation and erection of permanent pillars, if required on the identified CA land, shall be deposited in advance with the Forest Department by the user agency. The CA will be maintained for 10 years. The scheme may include afforestation of indigenous species with appropriate provision for anticipated cost increase for works scheduled for subsequent years.

- In compliance to the above, GAIL has transferred an amount of Rs 58,09,700/- vide UTR no. SBINR52025031078012573 dt. 10.03.2025 towards the cost of raising and maintaining the compensatory afforestation as per the approved CA Scheme which also includes the cost of survey, demarcation and erection of permanent pillars, if required on the identified CA land. The CA will be maintained for 10 years. The scheme may include afforestation of indigenous species with appropriate provision for anticipated cost increase for works scheduled for subsequent years. The copy of demand notes and payment receipt is enclosed as Annexure 2 (ii).

## 3. Net Present Value:

### i. User Agency shall transfer the funds towards the cost of Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the

- In compliance to the above, GAIL has transferred the amount of Rs. 18,15,601/- towards the cost of Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 06.01.2022 read with 22.03.2022 through online portal of CAMPA account of the State Concerned.
  - The details of the payments made towards NPV along with demand notices received from concerned DFOs, Payment Challan and Payment Receipt are enclosed as Annexure-3(i).
- ii. At the time of payment of the Net Present Value (NPV) at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India;**

- In compliance to the above, GAIL has submitted an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India. The undertaking is enclosed as Annexure-3(ii).

**4. Compensatory levies to be realized from the User Agency under the project shall be transferred/deposited, through e-payment module on PARIVESH portal (<https://parivesh.nic.in/>), into the account of CAMPA of the State concerned, managed by the National Authority (CAMPA);**

**5. The penalty for violation shall be equal to NPV of forest land per hectare for each year of violation from the date of actual diversion as reported by the inspecting officer with maximum up to five (5) times the NPV plus 12 percent simple interest from the date of raising of such demand till the deposit is made.**

**8. It has been observed that pits are visible over the DFL proposed for CA (as per the satellite imagery available on 29.04.2010). The suitability of the CA area in view of the same shall be ascertained by the state and if needed alternate DFL shall be provided for CA and requisite details shall be submitted prior to final approval.**

➤ In compliance to the above, the suitability of the CA land has been ascertained by the forest department and suitability certificate issued. Same is enclosed as Annexure-8.

**9. The reclamation of quarry should be done under the supervision of the State Forest Department. The quarry shall be reclaimed and afforested completely before the project is closed;**

**10. Overburden shall not be dumped outside the width of the RoW. The muck generated in the earth cuttings will be disposed of at the designated dumping sites and in no case the muck/debris will be allowed to roll down the hill slopes.**
