With respect to the subject cited above, it is to mention that the information regarding the short comings raised by IRO, Bhubaneswar, MoEFCC, Govt. of India vide F.No. 5-ORC426/2020-BHU dated 02-11-22 for grant of stage II clearance for diversion of 14.661 Ha. of forest land of 132 KV 2 Phase transmission line from existing 220/132/33 KV Grid sub-station at Therubali to 132/25 KV switch yard of RTSS, Bhalumaska under Rayagada forest division in Rayagada district of Odisha by M/S Odisha Power Transmission Corporation Ltd. (OPTCL) is given as under:

1)	The boundary of the forest land to be diverted has not been demarcated on ground by the project proponent.	The boundary of the forest lands of the said transmission line, proposed to be diverted has been demarcated on ground by the OPTCL, Rayagada Division. The DFO, Rayagada has also inspected the site on 04.03.2023 & on 06.03.2023 along with OPTCL officials & concerned Range officers. The Team visited 6 cement concrete pillars in reserve forest area and another 34 pillars in revenue forest area of different mouzas in Kolnara & Kalyansingpur Tahasil of Rayagada district & found that the Pillars are on ground with all details, as per norm. There is no deviation found in the field.
