In regard to above mentioned subject site (Hindustan Petroleum Corporation Ltd.) falls in village Sariana (Hadbast No. 349) Tehsil Mukerian District Hoshiarpur in the revenue estate in Khasra No.25//3, 25//4, 25//8/1 on Hajipur-Mansar road to village Sherkwil link road to Mansar side at a distance of 260 meter on the right side of road. Site falls in notified local planning area Talwara and its master plan is under preparation. NOC regarding this site has been issued by Execution Engineer construction Division P.W.D B&R branch Mukerian (Road authority) vide letter 423/M dated 19-07-2021 and this office has no objection to install retail outlet in this site as per town planning angle.


