



It is to submit that the Ministry of Environment, Forest & Climate Change, Government of India has accorded the Stage-I approval under Section-2 of the Forest Conservation Act, 1980 vide **letter No. IRO/KOL/SK/Others/146631/2021/186 date 26th May 2023** for diversion of 0.0116 Ha of forest land in favour of Central Water Commission for installation of Automatic Data Acquisition & Real Time Data Transmission System through Satellite for Rainfall, Water Level & Snow Measurement at 11 nos. of locations namely:-17th Mile Katao, Gurudongmar Lake, Yumesamdong, Dombang, Thangu, Yumthang Valley, Dombang Zero, Lachung, Samdong, Zema and Lachen in Mangan district of Sikkim.

Demand Note vide reference (1) cited above, was issued by Forests and Environment Department, Forest Secretariat, Deorali, Gangtok for the payment of **Rs.24,937/-** on the CA land (0.1 Ha) at the prevailing wage rates as per **compensatory afforestation scheme** and the payment of **Net Present Value (NPV) Rs.12,406/-** for the 0.0116 'Ha forest area to be diverted under this proposal, as per the order of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in IA No. 566 in WP (C) No. 202/1995 and the guidelines issued by the Ministry vide letters No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 & 5-3/2011-FC (Vol-I) dated 19/01/2022 in this regard.


