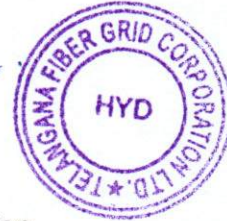

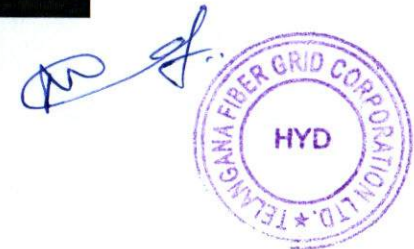

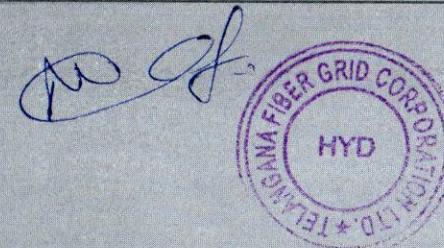

Please refer to the State Government letter No. 3407/For.I(1)/2022 dated 13.07.2022 and online proposal No. FP/TG/OFC/153136/2022 seeking prior approval of the Government of India in accordance with Section '2' of Forest (Conservation) Act, 1980 for the above-mentioned project.


After careful consideration of the proposal of the State Government, it is noticed the current proposal is for Re-diversion of 0.0468 Ha (for laying of Optical Fiber Cable by the Telangana Fiber Grid Corporation Ltd) of the already diverted forest area of 98.093 ha in favour of Hyderabad Growth Corridor Limited (HGCL) for Outer Ring Road. The purpose as well as the user agency in the instant proposal have changed. Telangana Fiber Grid Corporation Ltd submitted a No Objection Certificate issued by the primary user agency (HGCL) for the re-diversion proposal. I am hereby directed to convey the Central Government's *in-principle* approval (*Stage-I*) under Section '2' of Forest (Conservation) Act, 1980 for re-diversion of 0.0468 ha of forest land in Medchal division for Laying of OFC along the road within the existing RoW for execution of T-Fiber Project in Medchal District in favour of Telangana Fiber Grid Corporation Limited, subject to the following conditions: -

- (i) Legal status of the forest land shall remain unchanged.
- (ii) NPV and Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- (iii) No tree felling shall be carried out by the User Agency.
- (iv) As per the prevailing guidelines for re-diversion of forest land, the primary user agency shall not levie any fee/ charges from the new user agency for the use of the forest land.

- (v) All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal.



Adverting to the references cited above, it is submitted that vide reference 6th cited, the Prl. Chief Conservator of Forests (HoFF) while enclosing **in-principle (Stage-I) approval** accorded by the Government of India, Ministry of Environment & Forests, Integrated Regional Office, Hyderabad in the reference 5th cited, U/s 2 of Forest (Conservation) Act, 1980 for diversion of forest land to an extent of 0.0468 ha passing through Kandlakoya RF of Medchal forest division of Medchal District for laying of Optical fiber Cable for execution of T-Fiber Project in favour of M/s. Telangana Fiber Grid Corporation Limited subject to certain conditions stipulated therein and requested to submit the demand note through email to Nodal Officer (FCA) for vetting and raise the demand with the User Agency after approval, duly indicating the account into which the amounts to be deposited by the User Agency for making compensatory levies; and also to



submit the compliance report on conditions stipulated and furnish the same through APCCF/CF, Hyderabad for obtaining Stage II (final) approval from the competent authority.

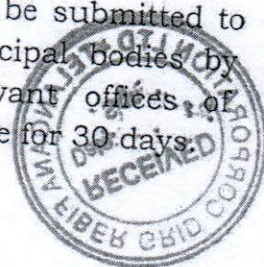
As seen from the conditions stipulated by State Government, the User Agency has to make payment of compensatory levies as follows:

Further, the User Agency is directed to deposit an amount of **Rs.44,824/- (Rupees Forty four thousand eight hundred and twenty four only)** in the Telangana State Compensatory Afforestation Fund Management and Planning Authority (CAMPA) saving bank Account **through online mode only, through e-portal method at MoEF&CC, GOI, New Delhi portal i.e., <http://parivesh.nic.in> by generating the challan in consultation with Nodal Officer, Telangana State Forest Department. The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. The payment to be made against the Challan. The Challan is valid for one week. A step-by-step process is available at <http://parivesh.nic.in>**

Further, the User Agency has to comply with following in accordance with the MoEF&CC, GoI instructions issued vide F.no.7-23-2012-FC, Dt.24.07.2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, Dt.23.08.2013:

1. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
2. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.



The user agency is requested to comply with the other conditions as directed in ref 6th cited and submit the compliance report alongwith all the required relevant information/documents etc. on the conditions stipulated by the Govt. in Stage I approval for obtaining Stage II (final) approval.

The UA will be requested not to carry out any work in violation of the Forest (Conservation) Act, 1980 and Wildlife (Protection) Act, 1972 without receipt of final clearance from the competent authority.

The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) approval or working permission.

It is therefore requested to kindly accord permission to issue demand notice to the user agency as per proposals submitted above.
