With reference to the letters 7th & 8th cited, the condition wise compliance report for the conditions stipulated in the "in principle" (Stage-I) approval accorded, vide Letter F. No.4-TSC324/2023-HYD/716, dated. 27.09.2023 of MoEF&CC, GOI, Sub Office (Regional Office, Chennai), for diversion of 13.195 Ha of forest land in favour of M/s. TSGENCO for Construction of Railway line (12.6203 Ha under

Rajagattu RF) from Vishnupuram Railway station to (5x800MW) Yadadri Thermal Power Station, Veerlapalem (V), Dameracherla (M), Nalgonda Dist and laying of Raw water pipe line (0.5747 Ha under Adavidevulapally RF) from the river Krishna to the above project, along with following documents in Eight (8) sets each are furnished herewith as Annexure.

- 1. Undertaking for various conditions stipulated in Stage I approval Eight (8) sets.
- 2. The copies of Mutation Certificate along with other documents such as Non-Encumbrance certificate, SOI topo map showing the mutated non-forest CA land and panchanamas of the non forest CA lands as handed over by the Revenue department, Nalgonda Dist.

Further, as directed by the PCCF (HoFF), Telangana and DFO, Nalgonda in the letters, a Public Notice was issued in two widely circulated daily news papers one in regional language (telugu) daily news paper i.e. "Namasthe Telangana and the other in English daily news paper i.e. "THE HINDU" on 10.10.2023 duly publishing the entire "In-principle (Stage –I)" approval granted in favour of TSGENCO along with the conditions and safe guards imposed by MoEF&CC, GoI, Sub-office (Regional Office – Chennai), Hyderabad in verbatim, for the use of forest land for non-forest purpose (Copies enclosed).

Also, the copies of the "In-principle (Stage –I)" approval were submitted to the connected heads of local bodies, Panchayats and municipal bodies by TSGENCO in addition to the relevant offices of the Government to display the same for 30 days (Copies enclosed).

As per the demand notice raised by the DFO, Nalgonda vide letter 8th cited, the following amounts were deposited in the designated accounts, towards NPV of forest land, raising and maintaining the CA in the degraded forest land (DFL) and non-forest CA land (NFL), cost of Wildlife mitigation measures and cost of construction of boundary pillars. The supporting copies for the payments made are herewith enclosed.



Compliance to the conditions stipulated in the 'In – principle' (Stage–I) approval accorded by MoEF & CC, GoI, Sub office (Regional office : Chennai), Hyderabad vide File No. 4-TSC324/2023-HYD/716, Dt: 27.09.2023, for diversion of 13.195 Ha of forest land in favour of M/s. TSGENCO for Construction of Railway line (12.6203 Ha under Rajagattu RF) from Vishnupuram Railway station to (5x800MW) Yadadri Thermal Power Station, Veerlapalem (V), Dameracherla (M), Nalgonda Dist and laying of Raw water pipe line (0.5747 Ha under Adavidevulapally RF) from the river Krishna to above project.

1. Condition (1):

The legal status of forest land shall remain unchanged

➤ Legal Status of the diverted forest land will be maintained as it is without any changes. In this regard, an undertaking is furnished.

2. Condition (2):

The DFO/FDO concerned shall ensure that no work shall takes place in the proposed forest area until the Central Government's formal approval (Stage-II) is issued.

➤ The work will be taken up by TSGENCO in the diverted forest area only after obtaining the Central Government's formal approval (Stage-II).

3. Condition (3):

Demarcation of the proposed forest area to be diverted shall be carried out by erecting a see-through wall of concrete and Chain link fencing along with the construction of 4 feet high cement concrete pillars duly numbered at an interval of 20 meters by the User Agency in consultation with the DFO concerned and report compliance.

- ➤ TSGENCO will carry out the demarcation of the proposed forest area to be diverted, by erecting a see through wall of concrete and Chain link fencing (Undertaking enclosed)
- ➤ TSGENCO, as per the demand notice received from the DFO, Nalgonda vide letter No. Rc.No. 4286/2019/S5, Dt.07.10.2023, has already deposited an amount of Rs. 33,00,000/- including admin charges @ 3% through RTGS vide UTR No: SBINR 52023101277560579 in the account of Forest Divisional Officer, Nalgonda, IDBI Bank, Nalgonda (A/c. No. 1128104000067157, IFSC Code: IBKL0001128) towards construction of 200 Nos boundary pillars by the forest department i.e. 150 Nos with 1.20 m height at every 20 m intervals both sides & at the edges of Railway line of 1280 m length and 50 No pillars in 430 m length along the raw water pipe line @ Rs. 15000/- per each pillar.

- 4. Condition (4): Compensatory Afforestation.
 - a) The State Forest Department shall raise and maintain compensatory afforestation plantations in non-forest land identified over an extent of 13.2653 ha in Sy.No. 229, Yellapurarm village, Tirumalagiri Sagar Mandal, Nagarjunasagar WLM division and an extent of 9.6657 Ha of degraded forest area in Compt.No. 72 of Nellikal RF of Nagarjunasagar Beat and Section of Nagarjunasagar Range at the cost of the User Agency. The CA shall be carried out as per the timeline provided in the FC Rules, 2022.
 - TSGENCO, as per the demand notice received from the DFO, Nalgonda vide letter No. Rc.No. 4286/2019/S5, Dt.07.10.2023, has deposited an amount of Rs. 5,38,89,349/- in Telangana CAMPA account through Ministry's portal for raising and maintaining Compensatory Afforestation plantations vide RTGS 59148038979, Challan dated. 12.10.2023 No. SBINR52023101277560602 on 12.10.2023 (i.e. Rs. 1,50,05,638/- towards Compensatory Afforestation (CA) in the Degraded Forest land over an extent of 9.6657 Ha in Compt. No. 72 of Nellikal RF, Nagarjuna sagar range & division and Rs. 3,88,83,711/- towards Compensatory Afforestation (CA) in the Non - forest land over an extent of 13.2656 Ha identified in Sy.No. 299 of Yellapuram (V) of Rajawaram RF of Nagarjuna sagar range & division. The copy of payment details is herewith enclosed.
 - b) The entire non-forest land proposed for CA over an extent of 13.2653 ha in Sy.No.229, Yellapuram Village, Tirumalagiri Sagar Mandal, Nagarjunasagar WLM division shall be transferred and mutated in the name of the Forest Department and notified as RF/PF prior to Stage-II approval. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act. 1927, or under the relevant section of the State Forest Act, shall be submitted by the State Government along with the compliance report.
 - An extent of 13.2653 ha. of non-forest land proposed for CA in Sy.No. 229, Yellapuram Village, Tirumalagiri Sagar Mandal, Nagarjunasagar WLM division has been transferred and mutated in the name of the Forest Department by the District Collector, Nalgonda/Revenue department. The copy of the mutation certificate is herewith enclosed.
 - c) The cost of compensatory afforestation at the prevailing wage rates as per the compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance by the project authority. The CA will be maintained

for 10 years. The scheme may include appropriate provisions for anticipated cost increases for works scheduled for subsequent years.

- ➤ TSGENCO, as per the demand notice received from the DFO, Nalgonda vide letter No. Rc.No. 4286/2019/S5, Dt.07.10.2023, has deposited an amount of Rs. 5,38,89,349/- in Telangana CAMPA account through Ministry's portal towards raising and maintaining Compensatory Afforestation plantations as mentioned above vide RTGS Challan No. 59148038979, dated. 12.10.2023 & UTR No. SBINR52023101277560602 on 12.10.2023. A copy of the payment details is herewith enclosed.
- d) The approved CA land and compensatory afforestation scheme shall not be changed without prior approval of the Central Government.
- The approved CA land will not be changed without prior approval of the Central Government.

5. Condition (5): Net Present Value:

- a) The State Government shall charge the Net Present Value (NPV) for 13.195 ha forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated. 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003. as well as letter No. 5-2/2006- FC dated 03/10/2006, 5- 3/2007-FC dated 05/02/2009 and revised NPV as per the Ministry's guideline No.5-3/2011- FC (Vo1-I) dated 06.01.2022 and clarification issued vide letter dated 19.01.2022 and 22.03.2022.
- TSGENCO, as per the demand notice received from the DFO, Nalgonda vide letter No. Rc.No. 4286/2019/S5, Dt.07.10.2023, has deposited an amount of Rs. 1,26,37,907/- in Telangana CAMPA account through Ministry's portal, towards Net Present Value (NPV) of the diverted forest land vide RTGS Challan No. 59148038979, dated. 12.10.2023 & UTR No. SBINR52023101277560602 on 12.10.2023. The copy of the payment details is herewith enclosed.
- b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

The Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, charged by the State Government, will be paid by TSGENCO (Undertaking enclosed).

6. Condition (6):

All the funds received from the User Agency under the project shall be transferred/deposited to CAMPA fund only through e-portal (https://parivesh.nic. in/);

All the funds towards cost of Net Present Value (NPV), Compensatory Afforestation, Implementation of wildlife Mitigation measures **CAMPA** transferred/deposited fund only through to e-portal (https://parivesh.nic. in/) and cost of boundary pillars is deposited in the designated account of FDO, Nalgonda.

7. Condition (7):

The UA / State Government shall implement all mitigation measures as proposed in the Wildlife Mitigation plan at the cost of the project. The annual report on the compliance of the same shall be submitted by the UA through the State Government.

- As per the demand notice received from the DFO, Nalgonda vide letter No. Rc.No. 4286/2019/S5, Dt.07.10.2023, TSGENCO has already deposited an amount of Rs. 65,00,000/- in Telangana CAMPA account through Ministry's portal vide RTGS Challan No. 59148038979, dated. 12.10.2023 & UTR No. SBINR52023101277560602 on 12.10.2023 towards implementation of wildlife mitigation measures in lieu of diversion of forest land to an extent of 13.195 Ha. for construction of Railway line from Vishnupuram Railway station to YTPS and laying of raw water pipe line from river Krishna to YTPS. The copy of the payment details is herewith enclosed.
- Further, the annual report on the compliance of the same will be submitted by TSGENCO through the State Government (Undertaking enclosed).

8. Condition (8):

Two rows of avenue plantation shall be raised by the user agency on the outer boundary of the forest land diverted for laying of the pipeline (either side) at the cost of the project. Two rows of avenue plantation will be raised on the outer boundary of the forest land diverted for laying of the pipeline (either side) at the cost of the project/TSGENCO, after taking over of the land and completion of erection of pipe line (Undertaking enclosed).

9. Condition (9):

The UA shall ensure that, while transporting of coal, all wagons are covered or sprinkled with water to avoid pollution in the forest area.

TSGENCO will ensure that, while transporting of coal, all wagons are covered or sprinkled with water to avoid pollution in the forest area (Undertaking enclosed).

10. Condition (10):

The UA shall undertake measures to prevent/ reduce noise, dust and light pollution in the forest land surrounding the proposed diversion area.

The measures to prevent/ reduce noise, dust and light pollution in the forest land surrounding the proposed diversion area will be taken up by TSGENCO during the operation/service of railway track (Undertaking enclosed).

11. Condition (11):

Tree felling shall be carried out wherever necessary under strict supervision of the DFO concerned.

Tree felling will be carried out wherever necessary under strict supervision of the DFO concerned (Undertaking enclosed).

12. Condition (12):

While executing the project, earth cutting involves the excavation of a huge quantity of materials, hence proper disposal plan to dispose of such excavated material shall be implemented in consultation with the DFO concerned and the UA shall not take soil from the nearby forest areas for execution of the project and no additional path/road shall be made to execute the project. The Debris/Muck and construction waste generated during the construction phase shall not be stored/ disposed in the forest area. It shall be disposed in designated waste disposal facility of the state government.

While executing the project, proper disposal plan to dispose of excavated material will be implemented in consultation with the DFO concerned as the earth cutting involves the excavation of a huge quantity of materials. Also,

TSGENCO will not take soil from the nearby forest areas for execution of the project and no additional path/road will be made to execute the project. The Debris/Muck and construction waste generated during the construction phase will not be stored/ disposed in the forest area. It will be disposed in designated waste disposal facility of the state government and tree felling will be carried out wherever necessary under strict supervision of the DFO concerned. In this regard, the undertaking is enclosed.

13. Condition (13):

A proper SMC plan shall be prepared and implemented to check soil erosion, at the project cost.

Speed regulating signage will be erected along the railway line at regular intervals in the Protected Areas/ Forest Area.

16. Condition (16):

The layout plan of the proposal shall not be changed without prior approval of the Central Government.

The layout plan of the proposal will not be changed without prior approval of the Central Government (Undertaking enclosed).

17. Condition (17):

Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourers after purchasing the same from the State

Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.

Sufficient firewood, preferably the alternate fuel, will be provided by TSGENCO to the labourers after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel (Undertaking enclosed).

18. Condition (18):

No additional or new path will be constructed inside the forest area for the transportation of construction materials for the execution of the project work.

➤ No additional or new path will be constructed inside the forest area for transportation of construction materials for the execution of the project work (Undertaking enclosed).

19. Condition (19):

The forest land shall not be used for any purpose other than that specified in the project proposal.

The forest land will not be used by TSGENCO for any purpose other than that specified in the project proposal (Undertaking enclosed).

20. Condition (20):

The forest land proposed to be diverted shall under no circumstances be transferred or sublet to any other agencies, department or person without prior approval of Govt. of India.

TSGENCO will not transfer or sublet the forest land proposed to be diverted, to any other agencies, department or person under no circumstances without prior approval of Govt. of India (Undertaking enclosed).

21. Condition (21):

Pre-fabricated structures should be used to the maximum possible extent to reduce the extent of disturbance in the habitat.

➤ TSGENCO will use the Pre-fabricated structures to the maximum possible extent to reduce the extent of disturbance in the habitat (Undertaking enclosed).

22. Condition (22):

Materials to be used for the construction of new tracks should be brought from outside the forest area.

The materials to be used for the construction of new tracks will be brought from outside the forest area (Undertaking enclosed) only.

23. Condition (23):

No labour camp shall be established on the forest land.

TSGENCO will not establish the labour camp on the forest land (Undertaking enclosed).

24. Condition (24):

The total forest area utilized for the project shall not exceed 13.195 Ha and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal. The User Agency shall furnish an undertaking to this effect.

The total forest area utilized for the project will not be exceeded 13.195 Ha and the forest area diverted will not be used by TSGENCO for any purpose other than those shown in the diversion proposal. (Undertaking enclosed).

25. Condition (25):

The User Agency and the State Government shall ensure compliance to all Acts, Rules, Regulations and Guidelines of the Ministry, for the time being in force, as applicable in Forest lands.

TSGENCO will ensure compliance to all Acts, Rules, Regulations and Guidelines of the Ministry, for the time being in force, as applicable in Forest lands (Undertaking enclosed).

26. Condition (26):

The user agency shall obtain all the permissions as applicable to the project from the concerned competent authorities.

> TSGENCO has already obtained required permissions/clearances applicable for the project from the concerned competent authorities.

27. Condition (27):

Any other condition that the DDGF (Central) Regional Office, Chennai or Sub Office, MoEF&CC, Hyderabad may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area shall be complied with by the User Agency.

Any other condition that the DDGF (Central) Regional Office, Chennai or Sub Office, MoEF&CC, Hyderabad imposed from time to time in the interest of afforestation, conservation and management of flora and fauna in the area will be complied with by TSGENCO (Undertaking enclosed).

28. Condition (28):

Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the prevailing provisions.

TSGENCO will not violate any of the conditions stipulated in the "In principle" (Stage - I) approval (Undertaking enclosed).

29. Condition (29);

The compliance report shall be uploaded on e-Portal (https://parivesh.nic.in/).

TSGENCO will upload the compliance report on e-Portal (https://parivesh.nic.in/). In this regard, the undertaking is enclosed.






