



Please refer to your letter cited in reference (ix) above vide which DFO Sanagreddy has been requested to offer his remarks on comments made therein. In response, DFO Sangareddy has furnished reply to CCF, Charminar Circle, Hyderabad. Copies of these letters are also addressed to this office.

2. DFO Sangareddy, in his reply for felling of trees, has reported to your good office that the cost of translocation of trees is not included in the FSR of Forest Department, or HMDA of GHMC. The DFO, Sangareddy further informed that total 948 numbers of trees are to be translocated. For which an amount of Rs.3,36,02,000.00 are to be deposited in PD account of District forest officer, Sangareddy.

Further, DFO, Sangareddy has informed that the proposed 6 no's culverts can be converted to passages which will act as under passes for the wild animals. Also, the DFO, Sangareddy, proposed an amount of Rs. 21,00,000.00 towards the wild life mitigation plan for Schedule-1 animals.



- In this regard, it is mentioned that that the translocation of trees will be executed by the EPC contractor through specialized/expert key personnel/Agency under the supervision of Forest department field officers. Detailed credentials of the Agency, in this regard, will be furnished to Forest Department for concurrence as discussed in meeting held on 28.04.2023 under the chairmanship of PCCF, Hyderabad at Aranya Bhavan in due course before starting of translocation of trees. Further, the necessary amount towards the mitigation plan may be paid to the PD account of DFO, Sangareddy by the User Agency.
- In view of the above, it is requested to issue working permission and Stage-II approval for forest land diversion proposal of subject work.
