I wish to invite your kind attention to the references cited above. As per the reference No.2, Stage-I approval has been accorded/diversion of 0.95 ha of the forest land for the Expansion Works of Government Arts and Science College, Jayankondam across Periyavalayam Reserved Forest in Ariyalur District. The diversion of forest land has been accorded with certain condition. On 13-04-2023 the User Agency has uploaded the compliance report. As per the reference No. 5 cited above, the User Agency is instructed to rectify the defects in the compliance report. As directed, the User Agency has rectified the defects and has uploaded the revised compliance report in the web portal on 26-04-2023. Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at cost of the User Agency.

Undertaking No 2 (vide GOI No.3)

Cement boundary wall to be constructed all along the proposed forest area for diversion and clear demarcation of forest and non forest area proposed to be utilize for construction of Arts & Science College.

Undertaking No 3 (vide GOI No.4)

Required number of plants Shall be raised and its maintenance for a period of 10 years shall be carried out over an extent of 1.90 ha degraded forest area in Vangaram RF, Ariyalur Range, at the cost of the User Agency.
