I submit that in the reference 1<sup>st</sup> cited above the Government has decided to accept the proposal (Stage I approval) under section 2 of Forest (Conservation) Act 1980 for diversion of 0.6339 ha of forest land in Naduhatty Reserve Forest of Nilgiris Forest Division for formation of cement concrete road to a length of 2332 m to a width of 3 meter through the Naduhatty Reserve Forest from Kallatty road to Naduhatty village panchayat road in the Nilgiris District to access the patta lands for cultivation purpose in favour of the Block development Officer (VP), Kotagiri Block, Kotagiri, The Nilgiris District for a period 30 years, under general category. Based on the stage I approval we have submitted compliance report for condition stipulated in the Stage-I approval for further action.

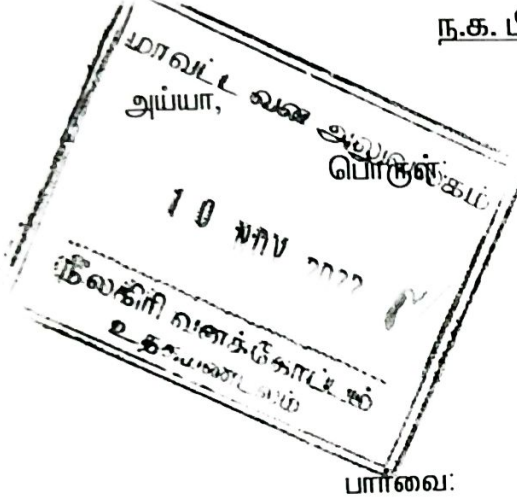
