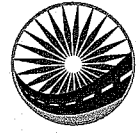

I invite your kind attention to the above subject matter, it is to informed that the proposal for diversion of forest land involved in Senjai East Reserve Forest for an extent of 150 Sq.m (i.e., 0.015Ha) has been submitted through online Parivesh Portal vide reference 1st cited for development of the subject project.

2. In this regard, the Government of Tamil Nadu vide reference 2nd cited has accorded In-Principle approval (Stage-I) Clearance under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.015Ha of Forest Land in Senjai East Reserve Forests for development of Karaikudi - Ramanathapuram NH 210 road project with certain conditions. report, the proposal will be considered for final approval and transfer of protected land to user agency shall not be effected prior to the issue of final approval.

3. Accordingly the same has been communicated by the Principal Chief Conservator of Forest, Chennai vide reference 3rd cited for furnishing compliance report to obtain Stage II final approval. Subsequently, the District Forest Officer, Sivagangai vide reference 4th & 5th cited has communicated the Stage-I Clearance with a request to erect a Cement Concrete Pillars and furnish compliance report along with acknowledgement for remittance of Net Present Value as mentioned in Annexure-II to this office for further processing.

4. In this connection, e-challan was generated & downloaded in portal on 17.12.2021 for remittance of NPV amount and the said amount of Rs.6570/- has been remitted through NEFT transfer on 20.12.2021 with UTR No.P354210143750003 in TAMILNADU CAMPA account.

5. Subsequently, the compliance on conditions spelt in In-Principle approval was complied and submitted by this office vide reference 6th cited. The Principal Chief Conservator of Forest, Chennai vide reference 7th cited has requested to submit revised compliance with all undertakings in web portal for processing further.
