As per the above Letter 3rd and 4th cited, Stage – I approval was given by the State Government with following conditions. I furnish here with the Compliance report on the conditions laid down by the Government of Tamilnadu in Stage – 1 approval for the Diversion of 0.32 ha of Forest Land in Moolakkadu & Pattrakadu RF area for the Construction of Retaining wall in various places of Polur – Jamunamarathur – Alangayam – Vaniyambadi road Km. 18/4 – 26/10 in Jamunamarathur Taluk of Tiruvannamalai District as below.
