Proposal for Diversion of 3.9375 Ha forest land in Sonlaur Reserve Forest for erection of 230 KV DC transmission line from Ottiyambakkam 400 KV Substation to Omega 230 KV Substation in Kanchipuram District in favour of Tamil Nadu Transmission Corporation, Chennai.

1.	The legal status of forest land shall remain unchanged.	Remains Unchanged.
2.	Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.	AS per the type design received from the District Forest Officer, Chengalpattu Division, the casting of pillars is erected in the site.
3.	The state Forest Department shall carry out Compensatory Afforestation (CA) and its maintenance in identified degraded forest area to an extent of 7.874 Ha in Sonalur RF at the cost of the user agency.	An amount of Rs.1,65,35,322 towards CA scheme and Rs.8,26,766 towards additional amount CA scheme has been transferred to state CAMPA accounts by generating challan in the MOEFCE web portal on 28.02.2022 challan copy enclosed.
4.	The degraded forest land identified for CA and CA scheme shall not be changed without the prior approval of the Central Government. In case, fencing or any other appropriate measure, if any, is necessary to protect the plantation from cattle grazing and local biotic pressure, same may be included in the CA scheme and such revised CA scheme may be submitted to this office for approval. 

21.	The total forest area utilized for the project shall not exceed 3.9375 Ha and the forest area diverted shall not be used for any purpose other than those shows in the diversion proposal. The user agency shall furnish an undertaking to this effect.	The total Forest area utilized for the project will not exceed 3.9375 Ha and Forest area diverted will not be used for any purpose other than the construction of transmission line.
22.	The approval under FCA, 1980 is subject to the clearance under all other Acts, Rules, Guidelines, Regulations and court orders applicable to such project.	Will be followed.

Any other conditions that the Central Government or regional Officer (Central) of Integrated Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User agency. 


