The Government of Tamilnadu has accorded Principal approval (Stage – I) vide Reference cited under section 2 Forest Conservation Act, 1980 for 0.0512 Ha for providing combined water supply scheme to Manmangalam and 71 other Habitations in Karur District.

2.	The demarcation of the proposed forest area shall be carried out by erecting 4 feet height cement concrete pillars duly numbered at an interval of 20 mts at the cost of User Agency.	The TWAD Board, RWS Division, Karur undertake the demarcation of the proposed forest land the work will be carried out by erecting 4 feet height cement concrete pillars duly numbered at an interval of 20 meters both sides in the diverted area at their cost after handing over of the 0.0512 Ha land. The undertaking to this effect is attached herewith.

The User Agency shall pay the Net Present Value of the diverted forest area at the rates stipulated by the Ministry of Environment and Forests from time to time, as per the orders of the Hon'ble Supreme Court Order Date: 28.03.2008 and 09.05.2008 in IA Nos. 826 in 566 with related IAS in Writ Petition (Civil) No. 202/1995 and Ministry's guideline No.5-3/2011-FC(Vol-I) Dated.06.01.2022 and Clarification issued vide letter Dated.19.01.2022 and 22.03.2022.	<p>The TWAD Board, RWS Division, Karur has already paid an amount of Rs.37,376/- for the Net Present Value (NPV) of the proposed forest area to be diverted (0.0512) as demanded by the Forest Department.</p> <p>The Transaction No. and date furnished below:</p> <p>Transaction No. 045920200321430205 Dated.20.03.2020</p>

The additional amount of the Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	The TWAD Board, RWS Division, Karur undertake to pay the additional amount of the Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future., The undertaking to this effect is attached herewith.
5.	All the funds should be remitted by the User Agency into CAMPA fund only by generating challan through e-portal. 13.	No labour camp shall be established on the Forest land.	The TWAD Board, RWS Division, Karur shall undertake regarding no labour camp shall be established on the Forest land.

8. Undertaking that the accepted and agreed to twenty years lease period and renewal proposal will be submitted before 6 months of expiry of lease with State Forest Department.

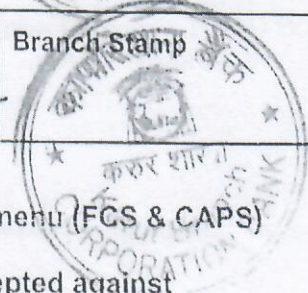
