I am to state that it has been intimated vide reference 1st cited the Government in Principles (Stage-I) approval has been accorded for laying of pipe at highways boundaries in West RF for a length of 1600m for the work of providing 0.70 MLD Water Supply To TNSCB Housing for All (HFA) Project Area for 1920 Tenements at Narimadu of Pudukkottai District and instructed to remit the net present value of Rs.78840/- .
