

The cost of the Compensatory Afforestation on the CA Land (0.45 Ha) as proposed by the state Forest Dept at the prevailing wage rate as per Compensatory afforestation scheme shall be deposited in advance with the state forest Dept by the Project Authority. The CA will be maintained for 10 Years.
