The CA will be maintained for 10 Years. The Scheme may include appropriate provision for anticipated cost increase for works schedule for subsequent years. Necessary payment has been made against DN No 2847/8-14 dated-08-Dec-2022 of DFO Kurseong amounting of RS.12,19,184/- though NEFT which is included in the same DN

1. Legal status of forest land proposed diversion shall remain unchanged	Agree
2. Compensatory afforestation shall be taken up by the forest dept over 1.53 ha degraded forest land (Location- Pathar Hirhira Block, Ghosh Pukur Range under Kurseong Forest Division) at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.	User Agency has got no role to play. Concern Forest Division may act accordingly.
3. Boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the direction of concern divisional forest officer.	User Agency has got no role to play. Concern Forest Division may act accordingly.





4. Wherever possible and technically feasible, the user agency shall undertake appropriate afforestation or vegetation enrichment measuring near sites related to the area diverted under the proposal in consultation with the state forest Dept at the project Cost.	Agreed
5. The lay out plan of the proposal shall not be changed without prior approval of the central government.	Agreed
6. A) The User Agency shall ensure that the labours and staff engaged in construction activity do not damage the nearby forest flora & fauna B) Earth & any other materials shall not be brought from and debris resulting during construction shall not be disposed of in the adjoin forest areas by the User Agency. C) No Labour Camp shall be established in the Forest land. D) The User agency shall provide alternate fuel preferably LPG to the labour & the staff working at the site so as to avoid any damage and pressure on the nearby forest area.	Agreed & ensured
7. A) The Forest land shall not be used for any purpose other than that specified in the project proposal. B) The period of diversion under this approval shall be co-terminus with the period of temporary use of the land. C) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or persons without prior approval of Central Govt.	Agreed & ensured
8. Any other conditions that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection & development of Forest & Wild Life.	Agreed.
