Sir,

On the above mentioned subject, it is requested to refer to the memo under reference, copy endorsed to the Managing Director, Odisha Mining Corporation Ltd. vide Memo cited above of even date wherein the Spl. Secretary to Govt., F & E Department has communicated the Stage-I approval granted by Eastern Regional Office, MoEF & CC, Govt. of India vide their Letter No. F. No.8-51/2018-FC dt. 17.09.2018. The MoEF & CC, Govt. of India have imposed 27 nos. of conditions to be complied by the User Agency. As per condition No. ii of Stage-I approval, the User Agency has to pay the Net Present Value (NPV) of the forest land as per the prevailing rate.

The Net Present Value (NPV) amount due for payment at the prevailing rate is as follows:-

It is therefore requested to deposit Rs.47,20,040 /- (Rupees Forty Seven Lakh Twenty thousand Forty) only through **e-payment module** of forest clearance website of MoEF & CC within a month of receipt of this letter failing which a simple interest of 9% per annum will be charged for each year.

It is further requested to submit the proof of deposit of the above amount for record and reference.
