MoEF & CC vide letter under reference (i) has clarified the following pertaining to Chrome (Block-II) exploration proposal of OMC.

"The user agency shall deposit Net Present Value (NPV) as specified in the condition no (ii) of the approval letter only for forest area within total lease area as per guideline no. 5-3/2007-FC dated 09/05/2018. It is further clarified that at the time of Stage-I approval, the above stated guideline was in vogue. Therefore, the provisions of para 6.8 of the latest guidelines no 5-2/2017-FC dated 28.03.2019, shall be applicable to the project proposals which have been accorded Stage I (In principle) approval on or after 28.03.2019".

In pursuance to the above direction of MoEF & CC, Govt, of India, OMC shall pay NPV @ 5.0 percent of the total forest land within the lease area having crown density up to 40%. The total forest land involved in Block-LPL is 239,709 ha. Therefore, the computation of NPV to be deposited by OMC comes to Rs. 2782852/s as detailed below:
