Sir,

This refers to letter No. F-4/13/2022/10-11/2511 dated 18/07/22 and even letter No. 402 dated 30/01/2023 of PCCF(LM) and Nodal Officer, Govt. of Madhya Pradesh on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Forest (Conservation) Act, 1980.

After due consideration of the proposal of the State Government, the "in-principle approval" of Central Government, is hereby conveyed for diversion of 3.00 ha Reserved Forest land for laying of 33 KV transmission line for providing power supply to the 1000 Beded Govt. Hospital under 220 KV Sub-station Ramsiya Sarkar Jhansi Road in favour of Project Engineer (E/M), P.I.U. in Gwalior District of Madhya Pradesh, subject to the following conditions and stipulations.

Conditions which need to be complied prior to handing over of forest land by the A: State Forest Department.

- The cost of compensatory afforestation on the CA land (6.00 ha DFL) at the prevailing (1)wage rates as per compensatory afforestation scheme (including the cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- The State Government shall charge the Net Present Value (NPV) for the 3.00 ha forest (2) area to be diverted under this proposal from the User Agency as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009, 5-3/2011-FC (Vol-II) dated 06/01/2022.

- (3) a) The User Agency in consultation with the State Forest Department prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in right of way under the transmission line for execution of the said scheme to the State Forest Department.
 - b) The User Agency will defray the cost of such plantation.
 - c) Cost of the same shall be transferred to CAMPA fund via online/e.portal.
- (4) All the funds received from the user agency under the project shall be transferred/ deposited in CAMPA fund only through e-portal (<u>https://parivesh.nic.in/</u>).
- (5) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- (6) NOC from concerned departments (Road, Canal, Railway etc.) shall be submitted before Stage-II approval.
- (7) The Geo coordinates of towers constructed in forest area shall be provided before Stage-II approval.
- (8) Towers so erected shall be fenced (chain link fencing) by the User Agency.
- (9) The KML files of diverted area and CA areas shall be uploaded on the e-Green watch portal with all requisite details prior to Stage-II approval.
- (10) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
- (11) The compliance report shall be uploaded on e-portal (<u>https://parivesh.nic.in/</u>).
- (12) In case the State Forest Department issues working permission, a copy of the same shall be submitted to this office.
- B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:
- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over **6.00 ha degraded forest land** at Compartment No. 34, Forest Range-Gwalior, Tehsil & District-Gwalior at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.
- (3) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- (4) User Agency shall restrict the felling of trees to **1251 numbers/minimum number** in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department and State Forest Department shall undertake the requisite felling.
- (5) The User Agency shall comply with the guidelines for laying transmission lines through forest as per Chapter 10 of FCA, 1980 Handbook, 2019.

- The user agency at its cost shall provide bird deflectors, which are to be fixed on (6)upper conductor of transmission line at suitable intervals to avoid bird hits.
- The boundary of the diverted forest land shall be suitably demarcated on ground at (7)the project cost, as per the directions of the concerned Dy. Conservator of Forest.
- Layout plan of the proposal shall not be changed without prior approval of the (8)Central Government.
- No labour camp shall be established on the forest land. (9)
- The User Agency shall provide alternate fuels preferably LPG to the labourers and (10)the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- No additional or new path will be constructed inside the forest area for (11)transportation of construction materials for execution of the project work.
- The period of diversion under this approval shall be co-terminus with the period of (12)the project life.
- The forest land shall not be used for any purpose other than that specified in the (13)project proposal.
- The forest land proposed to be diverted shall under no circumstances be transferred (14)to any other agencies, department, or person without prior approval of Central Government.
- The User Agency and the State Government shall ensure compliance to provisions of (15)all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- Any other condition that the Ministry of Environment, Forest & Climate Change may (16)stipulate from time to time in the interest of conservation, protection and development of forest & wildlife, shall be submitted.

After receipt of the compliance report regarding fulfillment of the conditions as stipulated above, from the State Government, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980.

This has been issued with the approval of the Competent Authority.
