

विषयः Diversion of 0.2239 ha. of forest land in favour of M/s. Juggler Hawk Industries Pvt. Ltd. for construction of approach road for proposed Bio-Diesel Plant, on NH-62 (Old-NH-15), (Chainage: 209+621 to 209+671) at Chak 7 BLW, SQ No. - Killa No. 21-25 at village-Kenchiya, Tehsil-Pilibanga-District.

महोदय,

उपरोक्त विषयक संदर्भित पत्र का आशय ग्रहण करने का कष्ट करें जिसके द्वारा विषयांकित प्रकरण में वन(संरक्षण) अधिनियम, 1980 की धारा(2) के अन्तर्गत भारत सरकार की स्वीकृति मॉगी थी।

प्रस्तुत प्रकरण के परीक्षणोपरांत मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु कुल 0.2239 हे0 संरक्षित वनभूमि के प्रत्यावर्तन एवं बिना वृक्ष पातन की सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों पर

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department for plantation of 225 trees (Compartment/ Survey No. 245/1, Range Nohar Village Sonari, Tehsil Nohar, District Hanumangarh) at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3. Revised CA scheme for plantation of 225 plants shall be submitted to this office.
- 4. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 5. The State Government shall charge the Net Present Value (NPV) for the 0.2239 ha. forest area to be diverted under this proposal from the user agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.
- Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to

- All the funds received from the user agency under the project shall be transferred/deposited to CAMPA 1. fund only through e-portal (https://parivesh.nic.in/). 8.
- The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- User agency shall use the land between entry and exit of Bio-Diesel Plant (156.00 m²) for plantation and 9. conservation of trees, the same shall be demarcated by 2 feet wall.
- Greenery will be maintained by user agency around Periphery of Bio-Diesel Plant. 10.
- 1). Plantation shall also be done along the inside boundary of Bio-Diesel Plant.
- 11. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection)
- The layout plan of the proposal shall not be changed without prior approval of Central Government. 12. 13.
- No labour camp shall be established on the forest land.
- 15. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any
- The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per 16. the directions of the concerned Divisional Forest Officer.
- No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- The period of diversion under this approval shall be co-terminus with the period of lease to be granted in 19. favour of the user agency or the project life, whichever is less.
- 19. The forest land shall not be used for any purpose other than that specified in the project proposal.
- The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, 20. department or person without prior approval of Govt. of India.
- Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and 21. action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018. 22.
- No violation of FCA certificate from concerned DFO shall be provided.
- The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/). 23.
- Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
