विषय: छिन्दवाड़ा जिले में ए.डी.बी. 6/7 योजना के अन्तर्गत तामिया- जुन्नारदेव मार्ग (राज्यमार्ग क्रमांक-41) उन् नयन/ चौड़ीकरण हेतु 5.70 हेक्टर (ऑनलाईन आवेदित 8.85 हे.) आरक्षित वनभूमि संभागीय प्रबंधक, मध् यप्रदेश सडक विकास निगम लिमिटेड को उपयोग पर देने बाबत ।

Sir.

This refers to letter No. F-5/1132/2022/10-11/1854 dated 26/05/2022 even letter No. 3276 dated 22/09/22 of PCCF(LM), and Nodal Officer, Govt. of Madhya Pradesh on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Forest (Conservation) Act, 1980.

After due consideration of the proposal of the State Government and on the decision of Regional Empowered Committee in its 7<sup>th</sup> meeting of 2022 on 18/11/2022, the "in-principle approval" of Central Government, is hereby conveyed for diversion of diversion of 5.70 ha (Online 8.85 ha) Reserved Forest land for widening of existing (State Highway No. 41) Tamia-Junnardev Road Package-III (Chindwara Division) in favour of Divisional Manager, Madhya Pradesh Road Development Corporation Ltd in Chhindwara District of Madhya Pradesh, subject to the following conditions and stipulations.

- A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.
- (1) The cost of compensatory afforestation on the CA land **8.850 ha non-forest land** at the prevailing wage rates as per compensatory afforestation scheme (including the cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- (2) The non-forest land shall be transferred and mutated in favour of State Forest Department and documents shall be submitted to IRO, Bhopal.
- (3) The non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation shall be declared as Reserved Forest or Protected Forest under the Indian Forest Act, 1927 or under the relevant Section(s) of the State Forest Act. Copy of notification shall be submitted with Stage-I compliance report.
- (4) The State Government shall charge the Net Present Value (NPV) for the **5.70 ha** forest area to be diverted under this proposal from the User Agency as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008,

- 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 & 5-3/2011-FC(Vol-I) dated 06/01/2022 in this regard in this regard.
- (5) All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e-portal (<a href="https://parivesh.nic.in/">https://parivesh.nic.in/</a>).
- (6) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- (7) The KML files of diverted area and CA areas shall be uploaded on the e-Green watch portal with all requisite details prior to Stage-II approval.
- (8) The User Agency shall submit Catchment Area Treatment (CAT) plan.
- (9) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
- (10) The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).
- (11) The State Forest Department shall raise plantation on road side or any other suitable places or degraded forest land at the cost of User Agency. The details shall be submitted to this office with compliance of Stage-I approval.
- (12) The State Forest Department shall submit a copy of working permission letter (if granted) with compliance of Stage-I approval as in case of linear proposal.
- B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:
- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over **8.850** ha non-forest land at Khasra No. 71/1, Village-Lahgadua, Tehsil- Tamia, District-Chhindwara at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species should be avoided.
- (3) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- User Agency shall restrict the felling of trees to 17 numbers/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- (5) The user agency shall construct under pass/over pass with consultation of State Forest Department, if required.
- (6) The User Agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.
- (7) Speed regulating signage will be erected along the road at regular intervals in the forest area.

- The boundary of the diverted forest land shall be suitably demarcated on ground at the (8)
- The layout plan of the proposal shall not be changed without prior approval of Central (9)
- No labour camp shall be established on the forest land. (10)
- The User Agency shall provide alternate fuels preferably LPG to the labourers and the (11)staff working at the site so as to avoid any damage and pressure on the nearby forest
- No additional or new path will be constructed inside the forest area for transportation of (12)construction materials for execution of the project work.
- The period of diversion under this approval shall be co-terminus with the period of the (13)
- The forest land shall not be used for any purpose other than that specified in the project (14)
- The forest land proposed to be diverted shall under no circumstances be transferred to (15)any other agencies, department, or person without prior approval of Central
- The State Government and user agency shall comply the provisions of the all Acts, Rules, (16)Regulation, guidelines, NGT order & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- (17)Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development

After receipt of the compliance report regarding fulfillment of the conditions as stipulated above, from the State Government, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980.

This has been issued with the approval of competent authority.
