

विषयः Diversion of 6.80 ha of forest land in favour of NHAI, Bikaner for development of Emergency Landing Facility on National Highway No. 11(old NH-15) from Km. 229.400 to km. 234.400 (old Km. 194.600 to 199.600) of Jaisalmer – Phalodi Section, in the state of Rajasthan.

महोदय.

उपरोक्त विषयक संदर्भित पत्र का आशय ग्रहण करने का कष्ट करें जिसके द्वारा विषयांकित प्रस्ताव पर वन (संरक्षण) अधिनियम, 1980 की धारा (2) के अन्तर्गत भारत सरकार की स्वीकृति मॉगी गयी थी।

प्रकरण को दिनांक—23.03.2021 को आहूत की गयी क्षेत्रीय सशक्त समिति (REC) की बैठक में (REC Agenda item 54.8-Raj.) शामिल किया गया था, बैठक में प्रकरण को स्वीकृति प्रदान की गयी है। क्षेत्रीय सशक्त समिति की स्वीकृति उपरान्त केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 6.80 है0 वनभूमि के प्रत्यावर्तन एवं 556 वृक्षों(4 पोल्स, 552 वृक्ष) के पातन की सैद्धान्तिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department over an area of 13.6 ha. double degraded Forest land in Compartment No. 02, Forest Block Tota, Village Tota, Range Chayan, District-Jaisalmer, Forest Block Bheekamkor, Village-Bheekamkor, Tehsil & Range Osiyan, District-Jodhpur at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 4. The State Government shall charge the Net Present Value (NPV) for the 6.80 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.
- Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- 6. User agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
