

Terms and Conditions:-

(A) Conditions which need to be complied prior to handing over of forest land by the J&K Forest Department.

- i) Cost of compensatory afforestation as per scheme may be realized from the user agency;
- ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per MoEF&CC directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008.
- iii) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- iv) The Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change www.parivesh.nic.in;
- v) User agency should ensure that the compensatory levies (CA cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance;
- vi) The cost of extraction shall be paid by the user agency to the agency executing the extraction (J&K Forest Department/J&K Forest Development Corporation/any other, as applicable);
- vii) Original copy of FRA certificate to be submitted;
- viii) The pipeline shall be laid down 1.5 meter below the ground and after laying down of pipeline the ground well be leveled.
- ix) Divisional Forest Officer, Ramnagar Forest Division shall furnish undertaking that the approved CA sites will not be changed without the approval of the Competent Authority.
- x) CEO CAMPA shall furnish undertaking that the funds under State CAMPA will be released to Divisional Forest Officer as per approved CA scheme.
- xi) The KML files of the area to be diverted, area accepted for raising CA, proposed SMC works, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.
- xii) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per law.



1036719/2022/O/6 CIH Forest **Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the J&K Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:**

- i) Legal status of the forest land shall remain unchanged;
- ii) Compensatory afforestation will be carried out over Degraded Forest land (DFL) upon 0.3208 ha of land on Comp No. 27a/N (Bari), Tehsil-Ramnagar, District-Udhampur, as per proposed CA scheme. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- iii) The layout plan of the proposal shall not be changed without prior approval of Central Government;
- iv) No labour camp shall be established on the forest land;
- v) Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- vi) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- vii) The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- viii) The forest land shall not be used for any purpose other than that specified in the project proposal;
- ix) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India; and
- x) The User Agency shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
- xi) Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

3 User Agency shall obtain Environment Clearance or any other clearance, if applicable under any act/rule/order/guideline etc for the proposal.

4. After receipt of the compliance report on fulfillment of the conditions under para-2, above, final approval order shall be given under Section-2 of the Forest (Conservation) Act, 1980. The use of forest land will not be allowed till final approval is accorded.
