Subject: Diversion of 0.93 Ha Protected Forest Land for Integrated Water Management Plan WD-II for Dapada, Moti Pati, Vasona and Chikhali villages in the UT of Dadra & Nagar Haveli.

Sir,

As per the power conferred under Order F. No. 11-9/98-FC dated 07.11.2014 by the Ministry of Environment and Forests, New Delhi the request of the Executive Engineer, PWD-III(Irrigation) (D.P.), DNH, Silvassa for diversion of 0.93 Ha Protected Forest Land for Integrated Water Management Plan WD-II for Dapada, Moti Pati, Vasona and Chikhali villages in the UT of Dadra & Nagar Haveli is considered and In-principle approval is accorded subject to the following conditions:-

- I. The legal status of the forest land shall remain unchanged i.e. shall remain Reserve / Protected / Village / other types of forests / forest as the case may be.
- II. No felling of tree shall be involved in the implementation of the proposal.
- III. The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.
- IV. The pipeline shall be along the road within existing right of way not falling in National parks and Wildlife sanctuaries.
- V. Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the Forest Department, DNH.
- VI. The User agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.
- VII. Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- VIII. The User agency shall seek permission from Forest Department, DNH for carrying out any maintenance.

- IX. The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
- X. The User Agency shall obtain the Environmental Clearance before issue the formal order.
- XI. All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.
- XII. All the fund received from the User Agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank A/c. No. SB01025204 (CAF D&NH) in Corporation Bank, Lodhi Complex New Delhi - 110003.
- XIII. The User Agency has to pay ₹ 10,88,524/- (Rupees Ten lakh Eighty-eight thousand, Five hundred and Twenty-four only) towards Compensatory Afforestation including maintenance for 10 years and ₹ 8,73,270/- (Rupees Eight lakh Seventy-three thousand Two hundred and seventy only) towards Net Present Value of land.
- XIV. The forest land shall not be used for any purpose other than that specified in the proposal.

You are therefore, requested to deposited ₹ 19,61,794/- (Rupees: Nineteen Lakh, Sixty-one thousand, Seven Hundred and Ninety -four only) through challan generated through online mode in favour of Compensatory Afforestation fund (CAF) Dadra & Nagar Haveli and copy of proof /evidence may be submitted to this office. The User Agency shall adhere to all the conditions indicated above.

The formal order for diversion of forest land to User Agency will be issued after above conditions are complied. In no case the work shall be started without a formal order from this office.
