Sir,

As per the power conferred under reference above by the Ministry of Environment and Forests, New Delhi the request of the Executive Engineer, PWD-II(Road), Dadra & Nagar Haveli, Silvassa for the diversion of 0.6 Ha. Reserved Forest land for construction of High Level Bridge connecting Dudhani and Kauncha villages in the U.T. of Dadra & Nagar Haveli is considered and in-principle approval is hereby accorded subject to the following conditions :-

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserve /Protected / Village / other types of forests / forest as the case may be.
- ii No felling of tree shall be involved in the implementation of this project.
- iii Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the Forest department, DNH.
- iv The User agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.
- v Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt

of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

- vi The user agency shall seek permission from the Forest Department, DNH for carrying out any maintenance.
- vii The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
- viii The User Agency shall submit the FRA Certificate in accordance with the provisions of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forests Rights) Act, 2006 before issue of formal approval.
- ix The User Agency shall obtain the Environmental Clearance before issue the formal order if applicable.
- x All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.
- xi All the fund received from the User Agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank A/c. No. SB01025204 (CAF D&NH) in Corporation Bank, Lodhi Complex New Delhi – 110003.
- xii The user agency has to pay ₹ 5,63,400/- (Rupees Five lakh, sixty-three thousand, four hundred only) towards Net Present Value of land and ₹ 8,26,549/- (Rupees Eight lakh, twenty-six thousand, five hundred and forty-nine only) towards Compensatory Afforestation including maintenance for 10 years.
- xiii The forest land shall not be used for any purpose other than that specified in the proposal.

You are therefore, requested to deposit an amount of ₹ 13,89,949/- (Rupees: Thirteen Lakh, Eighty-nine Thousand Nine hundred and forty-nine only) **through challan** generated through **online mode** in favour of Compensatory Afforestation Fund (CAF) Dadra & Nagar Haveli and copy of the proof / evidence may be submitted to this office. The user agency shall adhere to all the conditions indicated above.

The formal order for diversion of forest land to user agency will be issued after above conditions are complied. In no case the work shall be started without a formal order from this office.
