विषयांकित प्रकरण में सैद्धांतिक स्वीकृति जारी करने की अनुशंसा की गई है।

विषयांकित प्रकरण को भारत सरकार पर्यावरण एवं वन मंत्रालय के पत्र क.एफ.नं. 11–09/1998—एफ.सी. रायपुर दिनांक 3.01.2005, 11–09/1998— एफ.सी. रायपुर दिनांक 13.05.2011, तथा पत्र क.11— 9/98—एफ.सी. दिनांक 25.02.2016 में निहित प्रावधानों के तहत् विचारोंपरांत राज्य शासन एतद् द्वारा राजनांदगांव जिले के राजनांदगांव वन मंडल अंतर्गत प्रस्तावित नल जल योजना के तहत पेयजल आपूर्ति हेतु पानी के पाईप लाईन बिछाने हेतु 1.672 हे. वन भूमि के वन संरक्षण अधिनियम 1980 अंतर्गत व्यपवर्तन हेतु कार्यपालन अभियंता, लोक स्वास्थ्य यांत्रिकी खण्ड राजनांदगांव का को वन भूमि उपयोग पर देने हेतु निम्नलिखित शर्तों के अधीन सैद्धांतिक स्वीकृति दी जाती है:—

1. Legal status of forest land shall remain unchanged.

2. The State Government shall charge the Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the order of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition(Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02.2009 in this regard;

3. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as

per the final decision of the Hon'ble Supreme Court of India;

4. All the funds received from the User Agency under the project shall be transferred to Ad-hoc Compensatory Afforestation Fund (CAF)Chhattisgarh SB01025203 in account number CA25203 of Corporation Bank, Block- II, CGO Complex, Phase-1, Lodhi Road, New Delhi-110003.

5. The User Agency shall obtain the Environment Clearance as per the provision of the Environmental (Protection) Act, 1986, if required;

6. No labour camp shall be established on the forest land;

7. User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;

8. The boundary of the diverted forest land, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar;

- 9. The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- 10. Felling of trees on the forest land being diverted shall be reduced to the bare minimum and in no case exceed 50 trees per hectare. The trees should be felled under strict supervision of the State Forest Department;
- 11. The User Agency shall enumerate and provide, species wise and girth wise details, of the number of trees protected by above restriction and indicate before the stage II clearance.
- 12. Wherever possible and technically feasible, the User Agency shall undertake afforestation measures along the roads within the area diverted under this approval, in consultation with the State forest Department at the project cost.
- **13.** Overburden shall not be dumped outside the diverted forest area and in no case the muck/debris will be allowed to roll down the hill slopes.
- **14.** The User Agency will provide retaining walls, breast walls and drainage as per requirement to make the slope stable.
- 15. The forest land shall not be used for any purpose other than that specified in the proposal;
- 16. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department of person without prior approval of the Central Government;
- 17. No damage to the flora and fauna of the adjoining area shall be caused;
- **18.** The Nodal Officer, Forest Conservation Act 1980 shall complete settlement of right, in terms of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Right) Act, 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in its letter No. 11-9/1998-FC (pt.) dated 03.08.2009, in support thereof;
- 19. Any other condition that the State Govt. or the Ministry of Environment Forest and Climate Change Regional Office, Nagpur, may impose from time to time in the interest of conservation protection and development of flora and fauna of the area.
- **20.** The User agency shall submit the annual self compliance report in respect of the above conditions to the Nodal Officer, Forest Conservation Act 1980 and to the Ministry of Environment Forest and Climate Change Regional Office, Nagpur regularly.
- **21.** The User Agency and the Nodal Officer, Forest Conservation Act 1980 shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project.
- 22. Until Final Approval for this proposal is issued from the State Government, The User Agency would not be permitted to use the forest land by the Nodal Officer, Forest Conservation Act 1980.

Violation of any of these conditions will amount to violation of Forest (Conservation) Act,1980 and action would be taken accordingly.

The Nodal Officer Forest Conservation Act 1980 shall ensure compliance of all the above conditions.
