**विषय:** विश्व बैंक द्वारा वित्तपोषित उत्तर प्रदेश कोर रोड नेटवर्क विकास परियोजना के तहत हमीरपुर-राठ-गरौठा-गुरसराय-झासी राज्य राजमार्ग-42 के राठ बाईपास (हमीरपुर जनपद) से गरौठा (झांसी जनपद) (मिसिंग) लिंक किमी० 74.550 से किमी० 110.360 तक के उच्चीकरण निर्माण कार्य हेतु जनपद-हमीरपुर में प्रभावित 4.068 हे० आरक्षित एवं 1.0684 हे० संरक्षित वनभूमि कुल 5.1364 हे० वनभूमि के गैरवानिकी प्रयोग एवं बाधक 327 वृक्षों/पौधों के पातन एवं जनपद झांसी में प्रभावित 13.049 हे० आरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक 2127 वृक्षों/पौधों के पातन अर्थात् कुल 18.1854 हे० वनभूमि के गैरवानिकी प्रयोग एवं बाधक 2454 वृक्षों/पौधों के पातन की अनुमति के सम्बन्ध में।

महोदय,

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेश शासन के पत्रांक पी-17/81-2-2023-800(12)/2023, दिनांक 27.01.2023 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर वन(संरक्षण) अधिनियम, 1980 की धारा(2) के अन्तर्गत भारत सरकार की स्वीकृति माँगी थी।

प्रकरण को दिनांक 22.06.2023 को आहूत की गई क्षेत्रीय सशक्त समिति (REC) की बैठक में (REC Agenda item 6.5-UP) शामिल किया गया था। क्षेत्रीय सशक्त समिति (REC) द्वारा प्रकरण में स्वीकृति प्रदान की है। प्रकरण में विचारोपरान्त मुझे आपको यह सूचित करना है कि केन्द्र सरकार विश्व बैंक द्वारा वित्तपोषित उत्तर प्रदेश कोर रोड नेटवर्क विकास परियोजना के तहत हमीरपुर-राठ-गरौठा-गुरसराय-झासी राज्य राजमार्ग-42 के राठ बाईपास (हमीरपुर जनपद) से गरौठा (झांसी जनपद) (मिसिंग) लिंक किमी० 74.550 से किमी० 110.360 तक के उच्चीकरण निर्माण कार्य हेतु जनपद-हमीरपुर में प्रभावित 4.068 हे० आरक्षित एवं 1.0684 हे० संरक्षित वनभूमि कुल 5.1364 हे० वनभूमि के गैरवानिकी प्रयोग एवं बाधक 327 वृक्षों/पौधों के पातन एवं जनपद झांसी में प्रभावित 13.049 हे० आरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक 2127 वृक्षों/पौधों के पातन अर्थात् कुल 18.1854 हे० वनभूमि के गैरवानिकी प्रयोग एवं बाधक 2454 वृक्षों/पौधों के पातन की सैद्धांतिक स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है :-

1. Legal status of the forest land shall remain unchanged.
2. Compensatory afforestation shall be taken up by the Forest Department in an area of **2.13 ha. (DFL)** degraded forest land in District Hamirpur & **17.117 ha. (NFL)** non forest land in District-Hamirpur & Jhansi at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided. The details of area for CA is as follows:-

3. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with the Forest Department by the project authority. The CA will be maintained for 10 years. The scheme will be for plantation and may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
4. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
5. The non-forest land proposed for CA shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval. A copy of the original notification declaring the non-forest land under Section 4 or Section 29 of the Indian Forest Act, 1927, or under the relevant section of the State Forest Act as the case may be, will be submitted by the State Government at the time of submission of compliance of AIP.
6. The State Government shall charge the Net Present Value (NPV) for the 28.99 ha. forest area to be diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006 and 5-3/2007-FC dated 05/02/2009 in this regard.

**Revised amount of NPV as applicable as per orders dated 06-01-2022 and 19-01-2022 shall be deposited by User Agency in this regard.**

7. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
8. User agency shall restrict the felling of trees to 2454 trees/minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
9. **Roadside plantation shall be raised by SFD at the cost of User Agency and scheme for roadside plantation shall be provided.**
10. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
11. The Clearance of Standing Committee of National Board of Wild Life shall be submitted before the Final approval. No works shall be carried out in Forest land without approval of SCNBWL. Also an undertaking needs to be submitted by User agency that if clearance of SCNBWL is not accorded, then alignment shall be changed to avoid Protected Area.
12. Plantation shall be raised on both sides of the road and median (if available) by the State Forest Department at the cost of User Agency as per submitted scheme according to IRC guidelines and order passed by NGT in OA no. 27/2015 in the matter of Babulal Jaju v/s State of Rajasthan and others dated 16.11.2015.
13. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.
14. The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.





15. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
16. The layout plan of the proposal shall not be changed without prior approval of Central Government.
17. No labour camp shall be established on the forest land.
18. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
19. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
20. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
21. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
22. The forest land shall not be used for any purpose other than that specified in the project proposal.
23. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
24. The KML file of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before commencement of works.
25. Any order of Temporary Work Permission in case of linear projects for tree cutting and commencement of work as per clause 11.2 of FCA Guidelines shall be passed under intimation to Nodal office and this office. Order of Temporary Work Permission have to be uploaded on PARIVESH Portal as well. Nodal Officer will strictly monitor and ensure that no further activity is carried out under such permission after the expiry of one year from the date of issue of such permission.
26. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt. 29/01/2018.
27. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
28. All the funds received from the user agency under the project shall be transferred/ deposited to CAMPA fund only through **e-portal** (<https://parivesh.nic.in/>).
29. The compliance report shall be uploaded on **e-portal** (<https://parivesh.nic.in/>).

After receipt of compliance report on fulfillment of all of the above conditions from the State Government, proposal will be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980, by this office.

The order for transfer of forest land to user agency shall not be issued by the State Government till final approval order for diversion of forest land is issued by Government of India.


