विषय: अशोकनगर जिले में जल जीवन मिशन अन्तर्गत राजघाट समूह जल प्रदाय योजना के तहत भूमिगत पाईप लाईन, एम.बी.आर तथा पहुँच मार्ग निर्माण हेतु 3.885 हेक्टेयर आरक्षित एवं संरक्षित वनभूमि महाप्रबंधक, मध्यप्रदेश जल निगम मर्यादित, परियोजना क्रियान्वयन इकाई गुना को उपयोग पर देने बाबत (Online Proposal No. FP/MP/WATER/145554/2021).

Sir,

This refers to letter No. F-5/1322/2023/10-11/4081 dated 11/9/2023, 4931 dated 03/11/2023 and 2587 dated 15/05/2024 of APCCF(LM) & Nodal Officer, Govt. of Madhya Pradesh on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Forest (Conservation) Act, 1980.

After due consideration of the proposal of the State Government, "in-principle" approval of Central Government, is hereby conveyed for diversion of 3.885 ha Reserved & Protected Forest land for laying of underground drinking water pipeline, M.B.R and approach road under Rajghat Multi Village Scheme in favour of General Manager, Madhya Pradesh, Jal Nigam Maryadit, Guna in Ashok Nagar District of Madhya Pradesh, subject to following conditions and stipulations:

**A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.**

- (1) Cost of compensatory afforestation on the CA land **3.890 ha (out of 8.466 ha) non-forest land** at the prevailing wage rates as per compensatory afforestation scheme (including cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for the works scheduled for subsequent years.
- (2) **Non-forest land shall be transferred and mutated in favour of State Forest department and documents shall be submitted.**
- (3) **The non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation shall be declared as Reserved Forest under Section-4 or Protected Forest under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the State Forest Act. A copy of PF/RF notification may be submitted in Stage-I compliance report.**



- (4) The State Government shall charge Net Present Value (NPV) for the **3.885 ha** forest area to be diverted under this proposal from the User Agency as per orders of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009 & 5-3/2011-FC(Vol-I) dated 06/01/2022 in this regard.
- (5) All the funds received from the user agency under the project shall be transferred / deposited in CAMPA fund only through e-portal (<https://parivesh.nic.in/>).
- (6) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- (7) **Stage I approval is given with the intention that work can be started only after the proposal under the provision of FCA, 1980 submitted for construction of other components of the project is also approved.**
- (8) **DFO shall ensure that no other forest land is utilized for non forestry purpose during the implementation of this project other than that approved in this project.**
- (9) **The User Agency shall submit an undertaking that no muck shall be disposed off in forest land.**
- (10) The KML files of diverted area and CA areas shall be uploaded on the e-Green watch portal with all requisite details prior to Stage-II approval.
- (11) Violation of any of these conditions will amount to violation of the Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
- (12) The compliance report shall be uploaded on e-portal (<https://parivesh.nic.in/>).

**B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:**

- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over **3.885 ha (out of 8.466 ha) non-forest land, Survey No. 536 & 538, Village- Baghnari, Tehsil-Ishagarh, District- Ashok Nagar** at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially non-native species shall be avoided.
- (3) Additional amount of NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- (4) The User Agency shall restrict felling of trees to the enumerated **923** numbers / minimum number in the diverted forest land and the trees shall be felled under strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department and the State Forest Department shall undertake the fellings.
- (5) The State Government and user agency shall comply with the provisions of all the Acts, Rules, Regulation, guidelines, NGT order & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.



- (6) The Pipeline shall be laid 1.5 meter below ground and after laying of pipe line the ground shall be properly leveled.
- (7) The User Agency shall obtain Environmental Clearance as per provisions of the Environmental (Protection) Act, 1986, if applicable.
- (8) Boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- (9) Layout plan of the proposal shall not be changed without prior approval of the Central Government.
- (10) No labour camp shall be established on the forest land.
- (11) The User Agency shall provide alternate fuels preferably LPG to the labourers and staff working at the site so as to prevent any damage and pressure on the nearby forests.
- (12) The period of diversion under this approval shall be co-terminus with the project life.
- (13) The forest land shall not be used for any purpose other than that specified in the project proposal.
- (14) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of the Central Government.
- (15) Compliance of AIP in proposal no .FP/MP/IRRIG/532/2003 for construction of Rajghat canal accorded on 31.07.2007, shall be submitted.
- (16) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forest & wildlife.

After receipt of the compliance report regarding fulfillment of the conditions as stipulated above, from the State Government, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980.

This has been issued with the approval of competent authority.
