
As per the power conferred under Order F. No. 11-9/98-FC dated 07.11.2014 by the Ministry of Environment and Forests, New Delhi the request of the Executive Engineer (Irri.), PWD Civil Division No. III, District Panchayat, Dadra & Nagar Haveli, Silvassa for Diversion of 0.951 Ha. of Protected Forest Land for the Integrated Water Management Plan WD - III for Khadoli, Tinoda, & Bindrabin villages in the U.T. of Dadra & Nagar Haveli is considered and In-principle approval is accorded subject to the following conditions:-

- xiv. Proposed labour camps outside the forest area to be dismantled and removed. The labourers shall be sent back immediately after the completion of work.
 - xv. All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e.portal (<http://forestsclearance.nic.in>).
 - xvi. The User Agency shall transfer/deposit ₹ 11,91,172/- (Rupees : Eleven Lakh Ninety One Thousand One Hundred Seventy Two only) towards Compensatory Afforestation including maintenance for 10 years and ₹ 8,92,989/- (Rupees: Eight Lakh Ninety Two Thousand Nine Hundred Eighty Nine only) towards Net Present Value of the land (NPV).
 - xvii. The forest land shall not be used for any other purpose other than that specified in the proposal.
 - xviii. The compliance report shall be uploaded on e.portal (<http://forestsclearance.nic.in>).

You are therefore, requested to deposit ₹ 20,84,161/- (Rupees: Twenty Lakh Eighty Four Thousand One Hundred Sixty One only) through challan generated online mode in favor of Compensatory Afforestation Fund (CAF) Dadra & Nagar Haveli and copy of proof / evidence may be submitted to this office. The User Agency shall adhere to all the conditions indicated above.

The formal order for diversion of forest land to the User Agency will be issued after above conditions are complied. In no case, the work shall be started without a formal order from this office.
