- Cost of equivalent non-forest land as per State Govt. Policy may be vi) realized from the user agency.

vii) Here it is pertinent to mention that Election Commission of India vide its letter no. 437/PB-HP/2019/NS-1 dated 16.04.2019 has conveyed no objection to the proposals as made therein subject to the condition that no publicity should be given and no political mileage shall be taken by anyone.

2. The following conditions shall also be complied with after according final approval:-

- i) Legal status of the diverted forest land shall remain unchanged.
- ii) No tree will be felled in this case.
 iii) The forest land shall not be
- iii) The forest land shall not be used for any purpose other than that specified in the proposal and shall under no circumstances, be transferred to any one without prior approval of the Central/State Government.
- iv) The User Agency shall ensure, no damage is caused to the wildlife available in the area during or after execution of this project.
- v) The boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar.
- vi) The User Agency shall provide firewood preferably alternate fuels to the laborers and the staff working at the site so as to avoid any damage and pressure on the nearby forest area.
- vii) The User Agency shall obtain the Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if required.
- viii) As recommended by the Geologist and Task Force, the required soil conservation measures should be taken up by the user agency for which fund should be provided as per the current rate of works.
- ix) Muck disposal should be taken up as per the scheme approved by the Forest Department.
- x) No labour camp shall be established on the forest land.
- xi) The User agency shall submit the annual self-compliance report in respect of the above conditions to the State Government.
