**ORDER**

The Principal Chief Conservator of Forest (Forest Management) & Nodal Officer as per letter read above has recommended and forwarded the proposal for diversion of 0.01 ha of forest land in Peruthady Village, Kanhangad Range of Kasaragode Forest Division for construction of road through Achampara Vested Forest in Kasaragode District. The Secretary, Panathady Grama Panchayath is the user agency. The proposed project is for construction of road with 64 M length and 5 M width (Total area 0.0324 Ha) and is beneficial to 20 ST families.

2. Government have examined the proposal in detail and are pleased to accord sanction for the above proposal subject to the following conditions:-

1. Legal status of the forest shall remain unchanged.
2. The User Agency shall pay Net Present Value as per guidelines issued by Government of India.
3. The User Agency shall give an undertaking to pay additional Net Present Value if required.
4. The User Agency shall make payment of Compensatory levies as directed by the authorities.

5. The User Agency shall not fell any other trees or cause damage to the surrounding forest and shall take all possible measures to conserve the fauna and flora of the area.
6. The User Agency shall not use the forest land for any purpose other than the purpose for which the forest land is diverted.
7. When the forest land is no longer required for the purpose, the land will be resumed back to the Forest Department.
8. The User Agency shall abide by any other condition imposed later on by Government of Kerala / Forest Department/Government of India in the interest of Forest Conservation.
