In the letter 1st read above, the Principal Chief Conservator of Forests, Telangana State, Hyderabad has submitted a proposal for diversion of 0.31 Ha of forest land of Nizamabad Division for laying of Optical Fiber Cable along the road within the existing Right of Way in favour of M/s Reliance Jio Infocomm Limited.

2. Government, after careful examination of the proposal of the Principal Chief Conservator of Forests, Telangana State, Hyderabad, and in the light of the guidelines issued by the Government of India, Ministry of Environment & Forests, in the references 2nd to 4th read above, hereby accord permission to the Principal Chief Conservator of Forests, Telagana State, Hyderabad, for diversion of 0.31 Ha of forest land in Hajipur and Magdumpur Reserve Forests of Nizamabad Division for laying of Optical Fiber Cable along the road within the existing Right of Way in favour of M/s Reliance Jio Infocomm Limited, subject to fulfillment of the following parameters / conditions:-

General Conditions:

- The proposed work should be carried out without felling of trees and no cutting of branches is allowed;
- The maximum size of the trench is 2.00 mtrs depth and ii. 1.00 mtr width;
- iii. Laid out along the road and within the existing right of way;
- iv. The User Agency to make good the land after use/ maintenance;
- ٧. The User Agency to make good any loss to forests / environment;
- vi. The User Agency should take permission for carrying out any maintenance;
- The User Agency should pay compensation for the felled & vii. damaged trees, if any.

Special Conditions:

- The Legal status of the Reserve forest land proposed to be diverted does not change;
- ii. It is the responsibility of the User Agency to refill the trenches properly and fully so that it will not be hindrance for wild animals movement;
- iii. User Agency to put up two permanent boards (totally 8 boards) at the entrance and exist points of the RF about the status of the Land;
- iv. The maintenance works including cutting of branches of any sort, if taken up in future should be done with prior intimation and permission of the DFO, Nizamabad.
- 3. The Principal Chief Conservator of Forests, Telangana State, Hyderabad shall take necessary action accordingly in the matter.
