Diversion of 0.1124 ha of forest land in favour of Municipal Corporation Shimla for the construction of Ambulance road near New Judicial Courts Complex, Chakker, Shimla. (Kms 0/0 to 0/262) within the jurisdiction of Shimla Forest Division, District Shimla Himachal Pradesh,.

Sir,

Please refer to your subject cited proposal received on single file from you, seeking prior approval of the Government of HP for diversion of forest land for non forestry purpose under Forest (conservation) Act, 1980.

2. After careful consideration of the proposal, the State Govt. has decided to accord, "in-principle" approval of the above mentioned proposal subject to the compliance of the following:

1. Cost of compensatory afforestation as per proposed scheme may be realized from the user agency.
2. Net Present Value (NPV) of the forest land being diverted for non forestry purpose may be realized from the user agency as per Hon'ble Supreme Court of India's order dated 30.10.2002, 9.5.2008 and Ministry's directions issued vide letter Nos.5-3/2007-FC dated 5.2.2009.
3. The concerned DFO/CF shall deposit CA and all other funds with adhoc Body of Compensatory Afforestation Fund Management and Planning Author(CAMPA) through RTGS in Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498 Account No.344902010105419) or Corporation Bank, Lodhi Complex Branch, New Delhi-110003 (RTGS/ IFSC No.CORP0000371 Account No.SB01025210).
4. The use of forest land will not be allowed till final approval is accorded.
5. To provide GPS co-ordinates of the forest land proposed for diversion &CA.
6. Additional diversion of forest land for extension/strengthening of the road shall not be permitted within next five years.
