Subject: Diversion of 2.09 ha of forest land for laying of 110KV Double Circuit line on Kanuvai hill from Othakkalmandapam to Thudiyalur at Somayampalayam 110 KV SS in Coimbatore District

Sir,

Please refer to the State Government's letter No.6509/FR.10/2015-1 dated 11.05.2015 seeking prior approval of the Central Government in accordance with Section'2' of Forest (Conservation) Act, 1980 for the above mentioned project.

After careful consideration of the proposal of the State Government, I am hereby directed to convey the Central Government's in-principle approval (Stage-I) under Section'2' of Forest (Conservation) Act, 1980 for Diversion of 2.09 ha of forest land for laying of 110KV Double Circuit line on Kanuvai hill from Othakkalmandapam to Thudiyalur at Somayampalayam 110 KV SS in Coimbatore District in favour of Superintending Engineer, General Construction Circle, Tamil Nadu Transmission Corporation (TANTRANSCO), Tatabad, Coimbatore subject to the following conditions:-

- 1. The legal status of forest land shall remain unchanged.
- 2. The demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of User Agency, before Stage II clearance.

- 3. The cost of raising Compensatory Afforestation (CA) over 4.18 ha. of degraded forest land identified in Thenkkarai Village of Coimbatore District shall be realized from the User Agency.
- 4. The State Government shall charge the Net Present Value of the diverted forest land measuring 2.09 ha. from the User Agency as per the orders of the Hon'ble Supreme Court dated 28.03.2008 and 09.05.2008 in IA Nos.826 in 566 with related IA's in Writ Petition (Civil) No.202/1995.
- 5. Additional amount of Net Present Value (NPV) of the diverted forest land if any, becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be charged by the State Government from the User Agency. User Agency shall furnish an undertaking to this effect.
- 6. Cost of raising plantation of dwarf species preferably medicinal plants in the Right of Way under the transmission line shall be realized from the User Agency.
- 7. The funds received from the User Agency towards Compensatory Afforestation and Net Present Value under this project shall be deposited either in SB A/c No.SB01025227- CAF Tamil Nadu, Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110003 (RTGS/IFSC No.CORP0000371) or in SB A/c No. 344902010105 433- TAMIL NADU CAMPA, Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBIN0534498). The details of deposition of funds, inter-alia the DD Numbers & date, Amount, the Bank on which drawn and the date of deposition in the designated Bank shall also be furnished.
- 8. The User Agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted for the subject project.
- 9. Felling of trees shall be limited to the actual requirement of laying the transmission line which will not extend beyond 10 M width.
- 10. The total forest area utilized for the project shall not exceed 2.09 ha. The forest area diverted shall not be used for any purpose other than those shown in the diversion proposal.
- 11. The User Agency and the State Government shall ensure compliance of Ministry's guidelines F.No 7-25/2012-FC dated 5<sup>th</sup> May, 2014 and provisions of the all Acts, Rules, Regulation and Guidelines of the Ministry, for the time being in force, as applicable to the transmission line projects.

12. Any other condition that the Additional Principal Chief Conservator of Forests (Central), Regional Office, Chennai may impose from time to time for protection, improvement of flora and fauna in the forest area in public interest shall be complied by the user agency.

After receipt of the compliance report on the conditions stated above, the proposal will be considered for final approval. Transfer of forest land to the User Agency shall not be effected prior to the issue of final approval. This in-principle approval shall be valid for a period of 5 years only. In the event of non compliance of the above conditions, this in-principle approval shall automatically stand revoked after 5 years.
