Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may ii) be realized from the user agency, as per MoEF&CC directions issued vide letters No. 5-3/2007-FCdated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008.

CEO CAMPA shall furnish undertaking that the funds under State CAMPA will be

released to Divisional Forest Officer as per approved CA scheme.

The KML files of the area to be diverted, area accepted for raising CA, proposed SMC works, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II

- Violation of any of these conditions will amount to violation of Forest (Conservation) xii) Act, 1980 and action would be taken as per law.
- Conditions which need to be strictly complied on field after handing over of **(B)** forest land to the user agency by the J&K Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:

Legal status of the forest land shall remain unchanged;

i) Compensatory afforestation will be carried out over Degraded Forest land (DFL) upon ii) 0.4928 ha of land on Comp No. 40/Mbl, Tehsil-Ganderbal, District-Ganderbal, as per proposed CA scheme. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.

The layout plan of the proposal shall not be changed without prior approval of Central iii) Government;

No labour camp shall be established on the forest land; iv)

Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency v) to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;

No additional or new path will be constructed inside the forest area for transportation of vi) construction materials for execution of the project work;

The period of diversion under this approval shall be co-terminus with the period of lease vii) to be granted in favour of the user agency or the project life, whichever is less;

The forest land shall not be used for any purpose other than that specified in the project viii)

The forest land proposed to be diverted shall under no circumstances be transferred to ix) any other agencies, department or person without prior approval of Govt. of India; and

The User Agency shall ensure compliance of all the Court orders, provisions, rules, x) regulations and guidelines for the time being in force as applicable to the project.

- Any other condition that the Ministry of Environment, Forests & Climate Change may xi) stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
- User Agency shall obtain Environment Clearance or any other clearance, if applicable under any act/rule/order/guideline etc for the proposal.
- After receipt of the compliance report on fulfillment of the conditions under 4. para-2, above, final approval order shall be given under Section-2 of the Forest (Conservation) Act, 1980. The use of forest land will not be allowed till final approval is accorded.
