ORDER:

In the letter 1st read above, the Principal Chief Conservator of Forests, Telangana, Hyderabad has submitted a proposal under section-2 of Forest (Conservation) Act, 1980, for diversion of 0.372 Ha of Forest Land for formation of Link Road from existing CC Road to Undrugonda Laxmi Narasimhaswamy Temple in Indragonda RF in Compt. No. 15 in Nalgonda District in favour of Asst. Commissioner Endowment Department Nalgonda.

2. The proposal has been examined with reference to the guidelines issued by the Government of India in the letters 2nd to 5th read above.

3. Government after careful examination of the proposal and in exercise of the powers delegated to State Government in the guidelines issued by Government of India in the letters 2nd to 5th read above, hereby accord **in-principle (Stage.I) approval** for diversion of 0.372 Ha of Forest Land for formation of Link Road from existing CC Road to Undrugonda Laxmi Narasimhaswamy Temple in Indragonda RF in Compt. No. 15 in Nalgonda District in favour of Asst. Commissioner Endowment Department Nalgonda, subject to compliance of the following conditions:

- (i) The legal status of the forest land shall remain unchanged.
- (ii) The demarcation of the forest area proposed for diversion shall be carried out by erecting cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
- (iii) The User Agency shall pay the Net Present Value (NPV) of the diverted forest land as per the orders of the Hon'ble Supreme Court, dated: 28.3.2008 and 9.5.2008 in IA Nos. 826 in 566 with related IA's in Writ Petition (Civil) No.202/1995 and as per the orders issued by Government of Andhra Pradesh vide Go.Ms.No.124 EFS&T (For.I) Dept., dated:27.7.2010.
- (iv) Additional amount of the Net Present value (NPV) of the diverted forest land, if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the user agency. The user agency shall furnish an undertaking to this effect.
- (v) The additional amount of the Net Present Value (NPV) of the diverted forest land if any becoming due after revision of the same by the Hon'ble Supreme Court of India in future, shall be paid by the user agency and deposited either in SB A/c No. **037100101029963** of Corporation Bank, CGO Complex, Lodhi Road, New Delhi-110 003 (RTGS/IFSC

No.CORP0000371) or in SB A/c No. **344902010106351** of Union Bank of India, Sundar Nagar, New Delhi-110003 (RTGS/IFSC No.UBINO534498).

- (vi) The proposal shall be examined under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 as per the guidelines issued by Ministry of Environment & Forests vide letter No. 11-9/1998 - FC(Pt) dated. 5-7-2013 and requisite certificates / documents be furnished.
 - (vii) Other conditions specified in the G.OI, MoEF, letters dated. 13-5-2011, 16-6-2011 and 13.2.2014 shall also be complied with by Principal Chief Conservator of Forests, Telangana State, Hyderabad and user agency with which they are concerned.
 - (viii) The total forest area utilized for the project shall not exceed 0.372 ha. In case the land is not taken over by the user agency or the same is not used for the stipulated purpose within a period of two years, then the area shall be taken back by the Forest Department.
 - (ix) Transfer of forest land to the user agency shall not be affected prior to the issue of final approval. This approval shall be valid for a period of 5 years. In the event of non compliance of the above conditions, this approval shall automatically stand revoked.
 - (x) The User Agency shall erect fencing either side of the road to restrict the people not to enter into the forests.
 - (xi) The User Agency shall take measures to restrict the entry of people only for Darshan at the temple and not for any other purpose. No person should be allowed to stay in the nights in the temple area.
 - (xii) The User Agency shall also take measures that no person should be allowed to any kind of kindle of fire inside the forest.
4. On receipt of the compliance report of the above conditions, the proposal will be considered for final approval.

5. The Principal Chief Conservator of Forests, Telangana, Hyderabad, is therefore directed to take further necessary action accordingly in the matter.
