Government of India has accorded general approval under the Forest Conservation Act, 1980 vide letter No. F.No.5-2/2017-FC dated 28.03.2019 under para 4.2 according in the cases of laying of Underground Telephone Lines, Optical Fiber Cable/Underground Laying of Drinking Water Supply Pipeline.

. After careful consideration of the proposal submitted vide your letter under reference general approval of Govt. of India under Section 2 of Forest (Conservation) Act, 1980 for "In Principle Approval" diversion of 1.37 ha.of forest land for digging of trenches measuring 30300mtrs. long and 0.45 mtrs wide along the road for laying of Optical Fiber Cable Jio Digital Fiber Pvt. Ltd. is hereby conveyed subject to the following conditions:-

- 1. Legal status of the forest land will remain unchanged.
- 2. The forest land to be diverted as per in-principle approval will not be use for any other purpose.
- 3. No tree will be felled by the user agency in this case.
- 4. As per the order of the Hon'ble Supreme Court of India vide order dated 28-3-08 in I.A No. 826 in 566 in W.P.(C) 202 of 1995, the user agency is exempted for paying of the charges under NPV provided: (a) no felling of trees is involved and (b) the areas fall outside National Park/Wildlife Sanctuary.
- 5. User Agency has given Bank Guarantee of Rs. 7,57,500/- to **DFO**, **Gurdaspur**.
- 6. The Optical Fiber Cable will be laid along the road within the existing right of way and close to the outermost edge of the forest land. The dug out land shall be restored by the User Agency and the same shall be made good immediately after the approved operation.
- This approval is subject to the clearance of the proposal under relevant local
   Acts/Rules/Court's Rulings/instructions etc. as applicable.
- 8. The User Agency shall seek prior permission from the **DFO**, **Gurdaspur** for carrying out any maintenance operation.

- 9. The User Agency shall abide by any other condition (s) that may be imposed by this Department in the interest of afforestation and protection of environment.
- 10. The State Forest Department may revoke/suspend this approval, if any of the above conditions is not satisfactorily fulfilled by the User Agency.
- 11. An undertaking is signed by the User Agency for abiding by all the aforesaid conditions.
- 12. If any other NOC is necessary for the work under any Act/Rules/Guidelines etc. from other Departments, the user agency should obtain the same on its own before the commencement of laying of Cable.
- DFO, Gurdaspur shall ensure fulfillment of the above conditions and CF,Bist Circle, Jalandhar will supervise it.
