Subject: Diversion of 4.5769 ha. (3.2429 ha for ILS and 1.3340 ha for realignment of existing road) of forest land in Sy.No.12, Siriyuru village, Shivamogga District (Bhadravathi Forest Division) for construction of Instrument Landing System (ILS) in Shivamogga Airport for Social / Commercial purpose in favour of the Executive Engineer, Special Division, Public Works Department, Shivamogga -reg.

I am directed to refer to the State Government's letter No. FEE 06 FLL 2022 Sir, (e) dated 02/02/2022 and 15/06/2022 seeking prior approval of the Central Government under Section'2' of the Forest (Conservation) Act, 1980 for the above project.

The proposal was examined by the Regional Empowered Committee constituted under sub-rule (1) of rule 4A of the Forest (Conservation) Rules, 2003 in its meeting held on 29/06/2022 and 22/07/2022. During the REC meeting held on 22/07/2022, user agency informed the Committee that the forest land required for the project includes 3.2429 ha for construction of Instrument Landing System and 1.3340 ha for realignment of existing roads. This has also been confirmed by the user agency vide letter dated No.EE/PWD/Spl.Dvn/AE-01/Airport/ILS/2022-23/1309 dated 20/07/2022

After careful examination of the proposal of the State Government and on the basis of the recommendation of the Regional Empowered Committee meeting held on 22/07/2022, in-principle approval /Stage-I clearance of the Central Government is hereby granted for diversion of 4.5769 ha. of forest land (i.e., 3.2429 ha of forest land for construction of Instrument Landing System and 1.3340 ha of forest land for realignment of existing road) in Sy.No.12, Siriyuru village, Bhadravathi Forest Division Shivamogga District for Shivamogga Airport in favour of the Executive Engineer, Special Division, Public Works Department, Shivamogga, Bengaluru, subject to the following conditions: -

## A:Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

- The User Agency shall transfer online, the Net Present Value (NPV) of the forest land being diverted under this proposal, as per the guideline issued by Ministry vide letter No.5-3/2011-FC (Vol-I) dated 06/01/2022. The requisite funds shall be transferred through online portal into CAMPA account of the State Concerned.
- 2. The identified non-forest land over an extent of 9.88 ha in Sy No. 2, 3 and 4 of Emmedoddi village, Kudigere Hobli, Bhadravathi Taluk, Shivamogga District for raising Compensatory Afforestation (CA) shall be transferred and mutated in the name of forest department and notified as RF/PF prior to Stage II approval and copy of the RF/PF notification shall be furnished along with compliance report and also to be uploaded on PARIVESH web portal.
- 3. The User Agency shall transfer the cost of raising and maintaining the Compensatory Afforestation over double the extent of identified non forest land at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The scheme may include demarcation of non forest land using chain link fencing with provision for SMC works, planting of tall plants to ensure faster growth and appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- 4. The User Agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 5. All the funds received from the user agency under the project shall be transferred /deposited in CAMPA account only through e-portal (https://parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
- 6. The KML file of the area diverted and area proposed for CA (Non forest land as well as degraded forest land) shall be uploaded on the e-green watch portal with all requisite details and same shall be submitted along with compliance report.
- 7. The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).
- 8. The State Government shall complete settlement of rights, in term of the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act 2006, if any, on the forest land to be diverted and submit the documentary evidence as prescribed by this Ministry in it's letter No. 11-9/1998-FC dated 3<sup>rd</sup> August 2009 read with 05.07.2013 with necessary enclosures, in support thereof.
- 9. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost as per the directions of concerned Divisional Forest Officer. The boundary between the forest area and the area proposed to be diverted shall be fenced at the cost of the User Agency, to avoid

encroachment, man-animal conflict, etc.

- 10. Consent should be obtained from the concerned Gram Sabha/Panchayat for diversion/re-alignment of existing road which is passing through the proposed
- 11. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-FC dated 28.03.2019.
  - B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:

Legal status of the diverted forest land shall remain unchanged.

2. Compensatory Afforestation shall be raised over an extent of 9.88 ha of identified non-forest forest land within three years from the date of issue of final/Stage-II approval of diversion of proposed forest land and maintained thereafter by the State Forest Department at the cost of the User Agency and at least 1000 plants per hectare shall be planted over identified non-forest forest land. If it is not possible to plant so many saplings in the area identified for CA, then balance saplings will be planted in identified degraded forest land in Sy. No.32 of Guddadaneralakere village of Antheragange State Forest as per prescriptions of approved working plan with provision for ten years on subsequent maintenance and accordingly CA scheme shall be prepared.

3. At the time of payment of the Net Present Value (NPV) at the then prevailing rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.

4. All statutory clearances including Environment Clearance, if applicable shall be obtained before commencing the work in forest area.

5. Tree felling shall be restricted to the barest minimum possible and under confirmation from the local forest officials.

6. Suitable signages for speed regulation and animal safety will be erected along

the road through forest areas.

- 7. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 8. The total forest area utilized for the project shall not exceed 4.5769 ha.
- 9. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 10.No labour camp shall be established on the forest land.
- 11.Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 12. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government.
- 13. The forest land shall not be used for any other purpose other than that

specified in the project proposal.

- 14. No damage to the flora and fauna of the adjoining area shall be caused.
- 15. The layout plan of the proposal shall not be changed without the prior approval of the Central Government.
- 16. The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
- 17. The User Agency shall submit the annual self-compliance report in respect of the above stated conditions to the State Government and Integrated Regional Office, Bangalore by the end of March every year.
- 18. The user agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- 19. Any other condition that the Ministry of Environment, Forest and Climate Change may stipulate from time to time in the interest of conservation, protection and development of Forest and Wildlife.

After receipt of compliance report on fulfilment of the conditions mentioned above, the proposal shall be considered for final approval under Section-2 of the Forest (Conservation) Act, 1980. Transfer of forest land shall not be effected till final approval is granted by the Central Government in this regard.

Further, it may also be noted that this in-principle approval shall be valid for a period of 5 years from the date of issue of this letter. In the event of non-compliance of the above conditions, this in-principle approval shall be revoked after 5 years.
