Stage-I approval for diversion of 18.501 ha (Online proposed 18.33 ha) Reserved Forest land for construction of newly declare & existing State Highways Bhabhra-Kathiwada-Kheda Road under Package-3 (Dhar/Indore Division in favour of Divisional Manager, Madhya Pradesh Road Development Corporation Limited in Alirajpur District of Madhya Pradesh. (Online No. FP/MP/ROAD/138582/2021)

Sir.

This refers to letter No. F-5/1076/2021/10-11/3993 dated 01/12/2021 and even letter No. 1756 dared 19.05.2022 of PCCF(LM), Govt. of Madhya Pradesh on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Forest (Conservation) Act, 1980.

After due consideration of the proposal of the State Government and on the decision of Regional Empowered Committee in its 3<sup>rd</sup> meeting of 2022 on 29/04/2022, the "in-principle approval" of Central Government, is hereby conveyed for Diversion of 18.501 ha (Online proposed area 18.33 ha) Reserved Forest land for construction of newly declare & existing State Highways Bhabhra-Kathiwada-Kheda Road under Package-3 (Dhar/Indore Division in favour of Divisional Manager, Madhya Pradesh Road Development Corporation Limited in Alirajpur District of Madhya Pradesh, subject to the following conditions and stipulations.

- A: Conditions which need to be complied prior with handing over of forest land by the State Forest Department.
- The cost of compensatory afforestation on the CA land (20.80 ha Non Forest Land) at the prevailing wage rates as per compensatory afforestation scheme (including the cost of survey, demarcation and erection of permanent pillars etc. as required for securing the land against encroachment) shall be deposited in advance with the State Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- Non-forest land shall be transferred and mutated in favour of State Forest department and documents shall be submitted.
- The non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation shall be declared as Reserved Forest or Protected Forest under the Indian Forest Act, 1927 or under the relevant Section(s) of the State Forest Act. Copy of notification shall be sent in Stage-I compliance report.

- (4) The State Government shall charge the Net Present Value (NPV) for the 18.501 ha forest area to be diverted under this proposal from the User Agency as per the order of the Hon'ble Supreme Court of India dated 30/10/2002, 01/08/2003, 28/03/2008, 24/04/2008 and 09/05/2008 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by the Ministry vide letters No. 5-1/1998-FC (Pt.II) dated 18/09/2003, as well as letter No. 5-2/2006-FC dated 03/10/2006, 5-3/2007-FC dated 05/02/2009, 5-3/2011-FC(Vol-I) dated 06/01/2022.
- (5) The State Govt. shall be charged NPV as per MoEF&CC, New Delhi guideline No. 5-3/2011-FC(Vol-I) dated 06/01/2022.
- (6) All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e-portal (<a href="https://parivesh.nic.in/">https://parivesh.nic.in/</a>).
- (7) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- (8) The KML files of diverted area and CA areas shall be uploaded on the e-Green watch portal with all requisite details prior to Stage-II approval.
- (9) The error in the forest boundary shall be rectified in the data of FSI.
- (10) Plantation shall be carried out along the roadside, as per the availability of space.
- (11) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
- (12) The compliance report shall be uploaded on e-portal (https://parivesh.nic.in/).
- B: Conditions which need to be strictly complied on field after handing over of forest land to the User Agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval:
- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over 20.800 ha non-forest land at Khasra No. 2057, Village- Bada Khutaja, Tehsil-Chandrasekhar Nagar, District-Alirajpur at the cost of the user agency. As far as possible, a mixture of local native species shall be planted.
- (3) As far as possible, a mixture of local native species shall be planted under CA.
- (4) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall also be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.
- (5) User Agency shall restrict the felling of trees to 1662 numbers / minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- (6) The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost.
- (7) The layout plan of the proposal shall not be changed without prior approval of Central Government.
- (8) No labour camp shall be established on the forest land.
- (9) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.

- (10) User agency shall raise strip plantation on both sides and central verge of the road as per the IRC norms.
- (11) Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.
- (12) The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC, if any.
- (13) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- (14) The period of diversion under this approval shall be co-terminus with the period of the project life.
- (15) The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- (16) The forest land shall not be used for any purpose other than that specified in the project proposal.
- (17) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- (18) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department, or person without prior approval of Central Government.
- (19) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forest & wildlife.
- 2. After receipt of the compliance report regarding fulfillment of the conditions as stipulated above, from the State Government, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980. Transfer of forest land to user agency should not be given effect to by the State Government till formal order approving diversion of forest land is issued by the Central Government.
