Subject: Diversion of 0.75 ha forest land for installation of stone crusher 6/10 TPH at KM 13.00 on Naugam-Radha-Tutmarigali Road in Langate Forest Division by Border Roads Organization (BRO).

Ref: Online Proposal No. FP/JK/DEF/43723/2020.

Sir,

Please refer to the case of diversion of 0.75 ha forest land for installation of stone crusher as per online proposal referred above. I am directed to convey in-principle approval for diversion of 0.75 ha forest land for installation of stone crusher 6/10 TPH at KM 13.00 on Naugam-Radha-Tutmarigali Road in Langate Forest Division by Border Roads Organization (BRO) subject to the fulfilment of following terms and conditions:

- (i) Legal status of the forest land shall remain unchanged.
- (ii) Cost of Compensatory Afforestation, Net Present Value and other levies applicable shall be realized from the User Agency as summarized below:

Division	Net Present Value	Compensatory Afforestation	Total
Langate Forest Division	6,72,750/-	15,27,986/-	22,00,736/-

- (iii) Net Present Value (NPV) as summarized above shall be realized from the User Agency as per the various orders of the Hon'ble Supreme Court of India and as per the guidelines issued by the Ministry of Environment, Forest and Climate Change in this regard.
- (iv) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the Government from the User Agency.
- (v) The NPV of the forest land and all other CA levies shall be deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>). User Agency should ensure that the compensatory levies (CA cost, NPV, etc) are deposited through challan generated online on web portal and deposited in appropriate bank only. Amount


deposited through other mode will not be accepted as compliance of the Stage-I clearance.

- (vi) Revised Site Suitability Certificate for 0.75 ha to be submitted by concerned DFO.
- (vii) Divisional Forest officer shall furnish undertaking that the approved CA sites will not be changed without the approval of the Competent Authority.
- (viii) The CEO State CAMPA shall furnish undertaking that the funds under State CAMPA will be released to Divisional Forest Officer as per approved CA Scheme.
- (ix) User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.

The compliance report shall be uploaded by the User Agency on e-portal (<https://parivesh.nic.in>).

The use of forest land will not be allowed till final approval is accorded.
