Sub: Re-Diversion of 1.7830 ha. Forest land under section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for old Uran- Usar propane pipeline laying 12" dia Liquid Propane alone with OFC in Tal. Alibag, Dist. Raigad in the State of Maharashtra - regarding.

Sir,

The undersigned is directed to refer to the Government of Maharashtra's letter no. FLD-1324/C.R.88/F-10 dated 08.08.2024 and APCCF & Nodal Officer (FCA), Maharashtra Letter No. Desk-17/FCA-S1/PID-155620/Thane/2023-2024/327 dated 26.02.2024 on the above subject seeking prior approval of the Central Government under Section-2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. After careful examination of the proposal of the State Government, 'in-principle' approval was accorded by the Central Government vide its letter of even number dated 05.09.2024. The Addl. PCCF and Nodal Officer (FCA), Government of Maharashtra, vide his letter no. Desk-17/FCA-S2/PID-155620/Thane/2256/2024-25 dated 09.01.2025 submitted compliance report and requested to grant final approval to the proposal.

After careful consideration of the proposal and compliance report, I am directed to convey the Central Government's 'final approval' under Section- 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for Re-Diversion of 1.7830 ha. Forest land under section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for old Uran-Usar propane pipeline laying 12" dia Liquid Propane alone with OFC in Tal. Alibag, Dist. Raigad in the State of Maharashtra subject to the fulfilment of the following conditions:

i. Legal status of the forest land shall remain unchanged;

ii. The boundary of the diverted forest land shall be suitably demarcated on ground by the State Forest Department at the

cost of the User Agency;

- iii. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency;
- iv. No tree felling or cutting shall be permitted under instant proposal;
- v. The State Government, Maharashtra/ Nodal Officer (FCA), Maharashtra shall ensure settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (No. 2 of 2007) before issuing an order for handing over of forest land to the User Agency;
- vi. User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable;
- vii. The layout plan of the proposal shall not be changed without prior approval of Central Government;
- viii. The pipeline shall be laid down 1.5 meter below the ground and after lying down of pipe line the ground will be leveled;
- ix. No labour camp shall be established on the forest land;
- x. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel;
- xi. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work;
- xii. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less;
- xiii. The forest land shall not be used for any purpose other than that specified in the project proposal and diverted forest area shall not exceed 1.7830 ha;
- xiv. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India;
- xv. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam 1980 and action would be taken as per the provision of Adhiniyam and rules/guidelines issued there under;
- xvi. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife;
