विषय: पन्ना जिले के अन्तर्गत अजयगढ़-पन्ना 132 के.व्ही.डी.सी.एस.एस. लाईन के निर्माण हेत् 39.6945 हेक्टेयर संरक्षित वनभूमि एसोसियेट मैनेजर, एम.पी. पावर ट्रांसमिशन पैकेज-॥ लिमिटेड को उपयोग पर देने बाबत (Online Proposal No. FP/MP/TRANS/151776/2022).

Sir.

I am directed to refer to the PCCF (LM), M.P. letter Nos. F-4/22/2022/10-11/3206 dated 16/09/2022 and 2245 dated 31/05/2023 wherein prior approval of Ministry of Environment, Forest and Climate Change for diversion of 39.6495 ha Protected Forest land for laying of 132 KV DCSS ling Ajaygarh Substation to Panna Substation in favour of Associate Manager Project, M.P. Power Transmission Package-II Limited in Panna District of Madhya Pradesh was sought in accordance with Section-2 of the Forest (Conservation) Act, 1980. After due consideration of the proposal of the State Government, the 'in-principle' approval of the Central Government for diversion of the said forest land was accorded vide this office letter dated 03/07/2023 subject to fulfilment of certain conditions. The State Govt. of Madhya Pradesh vide their letter No. F-4/22/2022/10-11/4683 dated 19/10/2023 have furnished compliance report in respect of the relevant conditions stipulated in the in-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference and confirmation of receipt of compensatory levies from National Authority of CAMPA online e.portal dated 09/10/2023, final approval of the Central Government under Section 2 of the Forest (Conservation) Act, 1980 is hereby accorded for diversion of 39.6495 ha Protected Forest land for laying of 132 KV DCSS line Ajaygarh Substation to Panna Substation in favour of Associate Manager Project, M.P. Power Transmission Package-II Limited in Panna District of Madhya Pradesh, subject to following conditions and stipulations:-

- Legal status of the forest land diverted shall remain unchanged. (1)
- (2) Compensatory afforestation shall be taken up by the Forest Department over 80.00 ha degraded-Forest land at the cost of the user agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species, especially nonnative species shall be avoided. Details of CA areas are as follows:

(3) The State Government shall ensure that compliance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been completed

- (4) User Agency shall restrict the felling of trees to the **enumerated 9036 numbers/ minimum number** in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department and State Forest Department shall undertake the fellings.
- (5) The State Govt will provide the details and number of trees actually felled during laying of the proposed transmission line to the Regional Office, Bhopal for record purposes.
- (6) The User Agency shall comply with the guideline for laying of transmission lines through forest as per Chapter 10 of FCA, 1980 Handbook, 2019.
- (7) The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.
- (8) The user agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No. 7-25/2012-FC dated 05/-5/2014 & 19/11/2014.
- (9) Boundary of the diverted forest land shall be suitably demarcated on the ground at the project cost, as per directions of the concerned DFO.
- (10) Layout plan of the proposed diversion of the forest land shall not be changed without prior approval of the Central Government.
- (11) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- (12) No labour camp shall be established inside the forest land.
- (13) The User Agency shall provide alternate fuels preferably LPG to the labourers and staff working at the site so as to prevent any damage and pressure on the nearby forests.
- (14) The diverted forest land shall not be used for any purpose other than that specified in the project proposal.
- (15) The period of diversion under this approval shall be co-terminus with the project life.
- (16) The diverted forest land shall under no circumstances be transferred to any other agencies, department or person without prior approval of the Central Government.
- (17) All conditions of CWLW/SBWL/NBWL shall be strictly complied, wherever applicable.
- (18) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- (19) All the conditions of In-principle approval dated 03/07/2023 shall be strictly complied.
- (20) Violation of any of these conditions will amount to violation of the Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.

- (21) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests and wildlife.
- 2. As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to fulfillment of the stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop all the non-forest activities being carried out in the forest land besides initiating legal action as per provisions of Forest (Conservation) Act, 1980.

This has been issued with the approval of the Competent Authority.
