विषय: Diversion of 0.0972 ha of forest land in favour of Rajasthan Rajya Vidyut Prasaran Nigam Limited Hanumaangarh for 132 KV S/C Raisinghnagar-Jetsar (M/s NTPC) Transmission Line, District- Sri Ganganagar, Rajasthan (Total Length 17893 meters).

महोदय,


उपरोक्त विषयक शासन सचिव, वन विभाग, राजस्थान सरकार, जयपुर के पत्रांक प.1(87)वन/2021 दिनांक 10.11.2021 का आशय ग्रहण करने का कष्ट करें जिसके माध्यम से राज्य सरकार द्वारा विषयांकित प्रस्ताव पर केन्द्र सरकार से वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा (2) के तहत स्वीकृति मांगी गयी थी।

प्रश्नगत प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 22.12.2021 द्वारा सैद्धांतिक स्वीकृति प्रदान की गई थी जिसकी अनुपालना उपरोक्त संदर्भित पत्र द्वारा प्रेषित की गयी है। प्रस्तुत अनुपालना के अवलोकन पश्चात्, केन्द्र सरकार उपरोक्त विषयांकित परियोजना हेतु 0.0972 हे० वनभूमि के प्रत्यावर्तन एवं 10 वृक्षों के पातन की विधिवत् स्वीकृति (Final/ Stage-II Approval) निम्नलिखित शर्तों पर प्रदान करती है:-

1. Legal status of the forest land shall remain unchanged.
2. Forest land will be handed over only after required non-forest land for the project is handed over by the user agency.
3. Compensatory afforestation shall be taken up by the Forest Department for plantation of 100 saplings over an area of 0.50 ha degraded forest land in Village- Chak-1 As, Tehsil- Suratgarh, District- Sriganganagar, Rajasthan at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
4. The State Government should ensure submission of FRA certificate in proper format along with all the enclosures i.e. proceedings of DLC, SDLC & Gram Sabha Resolution by the User Agency before issuing the orders for diversion by the State Government.
5. User Agency shall restrict the felling of trees to 10 /minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
6. The User Agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 & 19/11/2014.

7. The User Agency shall comply with the guideline for laying transmission lines through forest areas issued by Ministry vide Chapter 10 of FCA, 1980 Handbook 2019.
8. The User Agency shall comply with the Hon'ble NGT order for transmission line dated 07.03.2012.
9. The layout plan of the proposal shall not be changed without prior approval of Central Government.
10. No labour camp shall be established on the forest land.
11. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
12. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
13. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
14. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the User Agency or the project life, whichever is less.
15. The forest land shall not be used for any purpose other than that specified in the project proposal.
16. The User Agency shall comply with all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
17. All the conditions of Stage-I/ In-principle approval shall be strictly complied.
18. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
19. Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
20. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
