Sub: Final (Stage-II) approval of Central Government under Forest (Conservation) Act 1980 for proposed diversion of 14.682 ha forest land in favour of District Collector, Birbhum for "Mega Tourism Project" at Tarapith under Birbhum Forest Division, West Bengal - reg

Sir,

This refers to letter No.1053-For/O/L/10T-02/2017 dated 3.04.2017, wherein prior approval of Ministry of Environment, Forest and Climate Change for diversion of 14.682 ha forest land in favour of District Collector, Birbhum for "Mega Tourism Project" at Tarapith under Birbhum Forest Division, was sought in accordance with Section-2 of the Forest (Conservation) Act, 1980. After due consideration of the proposal of the State Government, the 'inprinciple' approval of the Central Government for diversion of the said forest land was accorded vide Ministry's letter of even number dated 22.03.2018 and 1.11.2018 subject to fulfillment of certain conditions. The State Government of West Bengal vides their letter No.198-For/O/L/10T-02/2017 dated 8.02.2023 has furnished compliance report in respect of the relevant conditions stipulated in the in-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference, the **final approval** of the Central Government under Section 2 of the Forest (Conservation) Act, 1980 is hereby accorded for diversion of 14.682 ha forest land in favour of District Collector, Birbhum for "Mega Tourism Project" at Tarapith under Birbhum Forest Division, West Bengal, subject to the following conditions and stipulations:-

- (1) Legal status of the forest land diverted shall remain unchanged.
- (2) **Compensatory afforestation:** Compensatory afforestation shall be taken up by the Forest Department over 28.1985 ha. non forest land (Plot No. 602, J.L. No. 17, Khaitar No. 288, Mouza Sundarkhela, Block Rajnagar of Birbhum Forest Division) @ 1000 plant per hectare i.e. 14.682 X 1000 = 14,682 plants be planted as per Ministry's guidelines letter No. 11-

- 423/2011-FC dated 08.11.2017 at the cost of the User Agency. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- (3) The KML files of the area to be diverted and the CA area shall be uploaded on the e-Green watch portal before issue of final approval by the State Government of West Bengal.
- (4) The State Govt. will formulate the compensatory afforestation scheme including activities like soil and moisture conservation, regeneration cleaning, silvicultural activities and shall ensure maintenance of these plantations for a period of seven to ten years as per requirement.
- (5) The State Government shall ensure that compliance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been completed in accordance with the relevant Rules and Guidelines issued by the MoEF&CC, GoI in this regard.
- (6) The boundary of the forest land proposed to be diverted shall be demarcated on the ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, DGPS coordinates, distance from adjoining pillars etc. The work on these items should be completed within 6 months from the grant of final approval to diversion of forest land.
- (7) The Trees existing inside the proposed eco park shall be enumerated and equal number of indigenous trees to be planted and maintained at their own cost in consultation with the State Forest Department, since the existing number of trees are likely to be felled for development of the area.
- (8) The user agency shall not construct any building of permanent nature except one sewerage treatment plant and ecc-park consisting of miniature structures of 51 Satipithas under the project.
- (9) The State Govt./User Agency shall take up extension activities to promote environment awareness among tourist visiting the site.
- (10)The user agency shall ensure the compliance solid waste disposal measures as proposed.
- (11)The User Agency shall carry out plantation of small / ornamental trees on the available vacant space in the proposed area.
- (12)The layout plan of the proposed diversion of the forest land shall not be changed without prior approval of Ministry of Environment, Forest and Climate Change.
- (13)a) All the natural streams and water bodies in surrounding area shall be protected.

- b) The User Agency shall ensure that the labourers and staff engaged in construction activity do not damage the nearby forest flora and fauna.
- c) Earth or any other material shall not be brought from and debris resulting during construction shall not be disposed of in the adjoining forest area by the user agency.
- d) No labour camp shall be established inside the forest land.
- e) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
- (14)a) The diverted forest land shall not be used for any purpose other than that specified in the project proposal.
 - b) The period of diversion under this approval shall be co-terminus with the period of the project life.
 - c) The diverted forest land shall under no circumstances be transferred to any other agencies, department, or person without prior approval of the Ministry of Environment, Forest and Climate Change.
- (15) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- (16) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- (17)Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests and wildlife.
- 2. As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Integrated Regional Office of the Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop the non-forest activity being carried out in the forest land besides initiating the legal action as per provisions of Forest (Conservation) Act, 1980.
